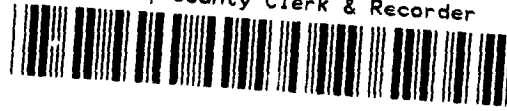


THAT CERTAIN OFFER OF DEDICATION made by Esther C. Garcia, per document recorded March 2, 2005, as Document No. 2005-0167098 of Official Records of Riverside County, California; the real property described in said document is also described in Exhibit "A" attached hereto and incorporated herein by this reference.

WHEREAS the offer of dedication and the consent to accept it by the designated officer of said City dated February 16, 2005, did not constitute acceptance of the offer of dedication, but said City, through its City Council, reserved all rights to accept the offer of dedication at any time thereafter.

Now therefore, pursuant to adoption of Resolution No. 21027 of the City Council of the City of Riverside, California, and the authority conferred therein, the undersigned officer on behalf of said City Council hereby accepts this irrevocable offer of dedication for public street an highway purposes to become known as Peggy Lane, together with all rights to construct, operate and maintain utilities, sanitary sewers, storm drains and other improvements consistent with the use as a public street and highway and consents to the recordation of this acceptance pursuant to Government Code Section §27281.

THAT CERTAIN REAL PROPERTY IN LOT 6, IN BLOCK 9 OF CHADBOURNE HEIGHTS, IN THE CITY OF RIVERSIDE, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, AS SHOWN ON MAP FILED IN MAP BOOK 12, PAGES 11 THROUGH 13, INCLUSIVE, IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY, DESCRIBED AS FOLLOWS:


BEGINNING AT THE INTERSECTION OF THE EASTERLY LINE OF SAID LOT 6 WITH A LINE THAT IS PARALLEL WITH, AND 117.50 FEET SOUTHERLY, MEASURED AT RIGHT ANGLES, FROM THE NORTHERLY LINE OF SAID LOT 6;

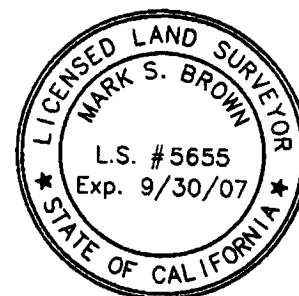

THENCE SOUTHEASTERLY, EASTERLY AND NORTHEASTERLY ALONG SAID NON-TANGENT CURVE, THROUGH A CENTRAL ANGLE OF $136^{\circ}32'14''$, AN ARC DISTANCE OF 107.25 FEET TO A POINT ON SAID EASTERLY LINE;

THENCE NORTH $09^{\circ}36'34''$ EAST ALONG SAID EASTERLY LINE, A DISTANCE OF 40.50 FEET TO THE POINT OF BEGINNING.

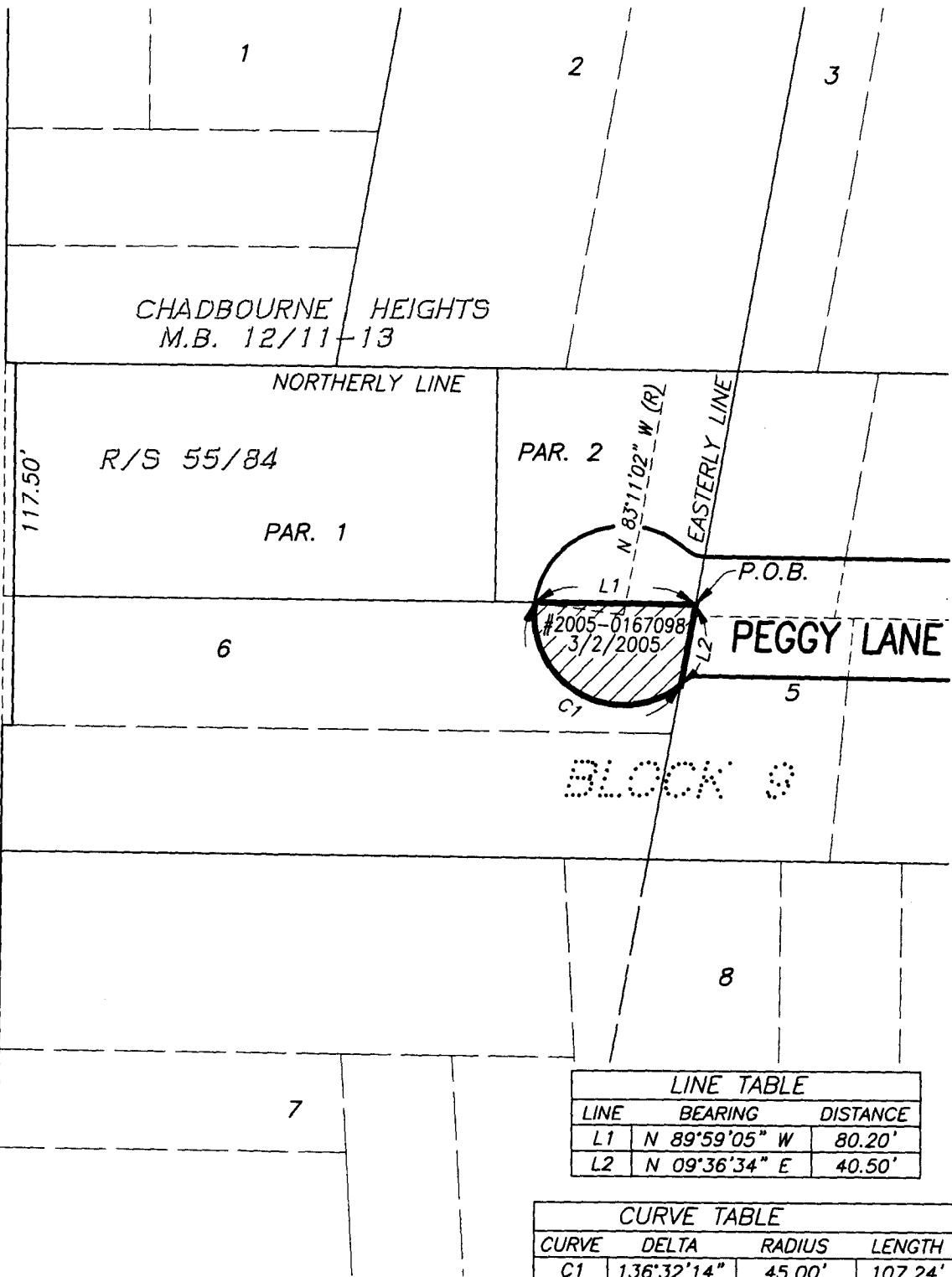

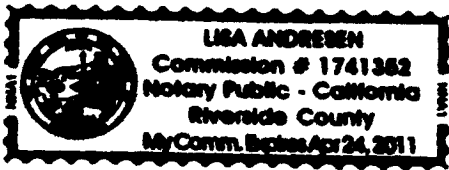
