A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA CHANGING THE STREET NAME OF WONG WAY, BETWEEN PALM AVENUE AND PINE STREET TO WONG STREET.

WHEREAS, on May 16, 1961, the City Council held a public hearing and by Resolution Number 9133, approved the street name change of the connector street between Palm Avenue and Pine Street to Wong Way; and


WHEREAS, a request has been made for a street name change from Wong Way to Wong Street.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:


Section 1: That portion of Wong Way as described by Exhibit "A" attached hereto and incorporated herein by reference, is hereby changed to Wong Street.





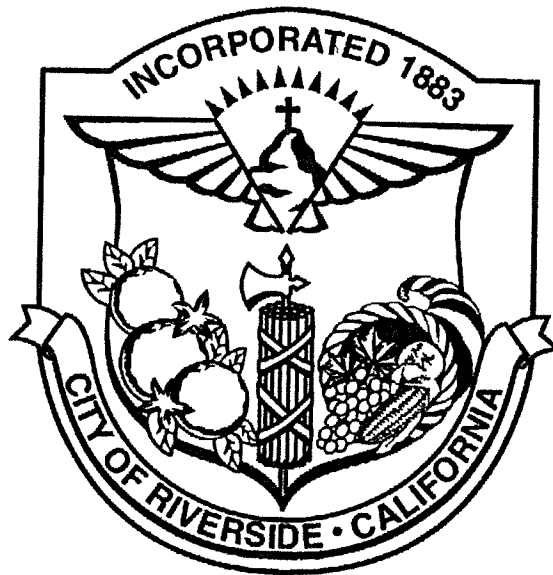
