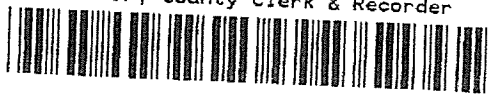

NOTICE IS FURTHER GIVEN that pursuant to Section 9538 of the Streets and Highways Code, assessments originally levied which are included within the



reassessments are superseded and supplanted by the reassessments; provided, however, that pursuant to said Section 9538, the lien of the original assessment is not superseded and supplanted and continues with respect to the unpaid installments of the assessments originally levied and the penalties and interest thereon, including the installments which have been posted to and are to be collected on the tax assessment roll for the 2011-12 fiscal year and all unpaid and delinquent installments of such assessments which were posted to the tax assessment roll for prior fiscal years, and which are not included in the reassessments. The original assessment is referenced in the Notice of Assessment which was recorded in the Official Records of the County of Riverside on June 28, 2001 as Document No. 2001-296284.

Reference is made to the reassessment diagram and reassessment roll recorded in the office of the Superintendent of Streets of the City of Riverside.

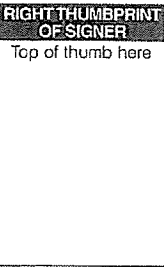
