RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF RIVERSIDE VACATING A PORTION OF WILLOW STREET IN SAID CITY.

WHEREAS, the owners of all the property abutting on Willow Street between Park Avenue and Woodbine Street in the City of Riverside, have petitioned the Common Council of this city to abandon said portion of said street, and which petition was presented to said Common Council of said city and filed on the 1st day of April, 1913,; and,

WHEREAS, in the opinion of the Council it is deemed advisable to vacate said portion of said street,

NOW THEREFORE BE IT RESOLVED, that that portion of Willow Street between the Southerly property line of Woodbine Street and the Westerly boundary line of Park Avenue in said city, be and the same is hereby abandoned and vacated as a public street.
