RESOLUTION NO. 21957

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA CHANGING THE STREET NAME OF A PORTION OF CHICAGO AVENUE BETWEEN BOBBITT AVENUE AND VAN BUREN BOULEVARD TO ALTA CRESTA AVENUE.

WHEREAS, the Planning Division of the Community Development Department, on behalf of local residents, requested a street name change of a portion of Chicago Avenue, between Bobbitt Avenue and Van Buren Boulevard, to Alta Cresta Avenue; and

WHEREAS, the Planning Commission considered Case P09-0672 at a public hearing held December 3, 2009, and approved the street name change of a portion of Chicago Avenue, between Bobbitt Avenue and Van Buren Boulevard, to Alta Cresta Avenue; and


WHEREAS, on January 5, 2010, the City Council held a public hearing and after considering all of the testimony both written and oral, approved the name change.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:


Section 1: That portion of Chicago Avenue between Bobbitt Avenue and Van Buren Boulevard as shown on the map in the attached Exhibit "A", and incorporated herein by reference, is hereby changed to Alta Cresta Avenue.

Section 2: The City Clerk of the City of Riverside is hereby authorized and directed to cause a certified copy of the Resolution to be recorded in the office of the County Recorder of Riverside County, California.

ADOPTED by the City Council this 5th day of January, 2010.

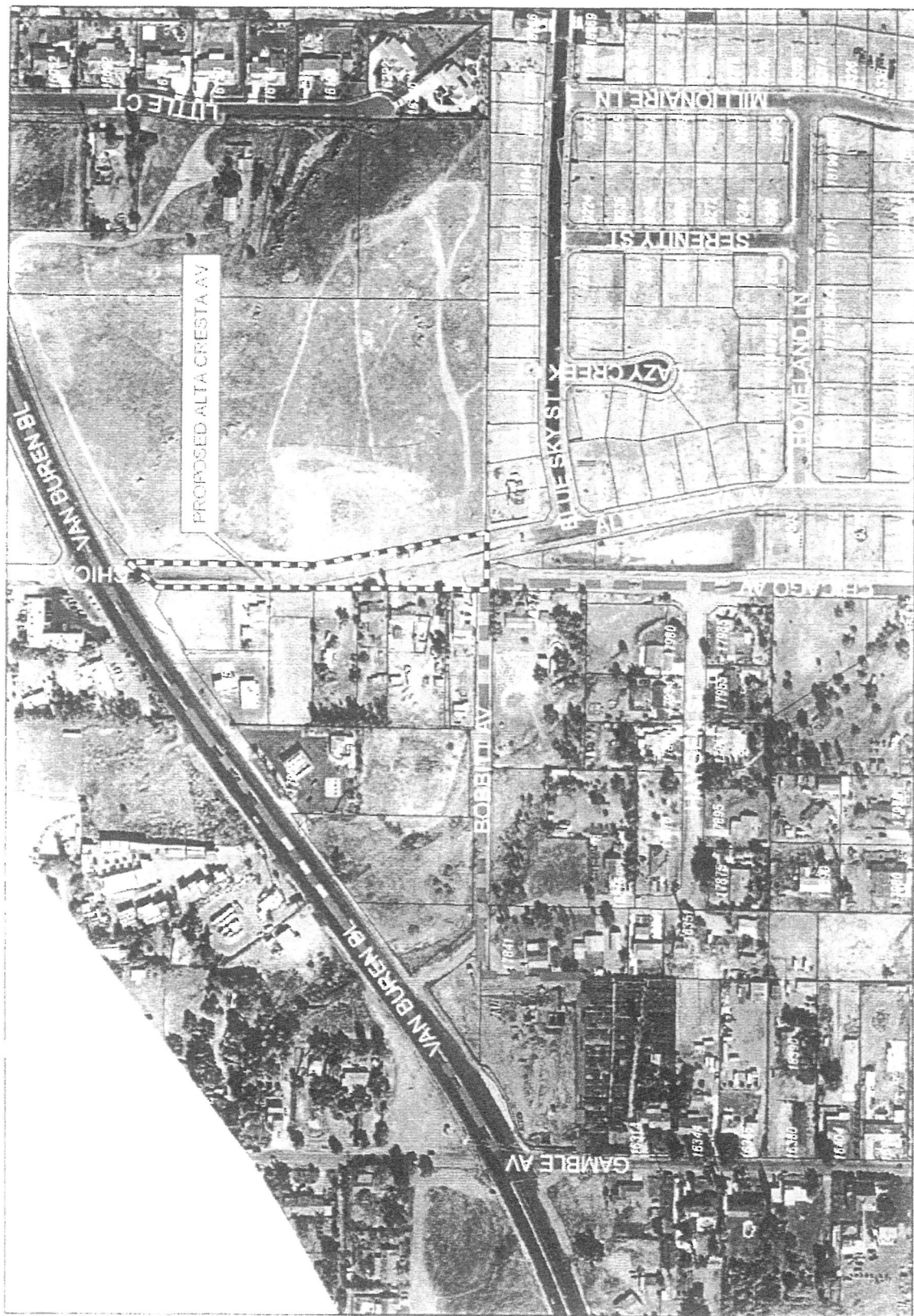
