A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING THE ORDER VACATING AN ALLEY.

WHEREAS, on October 18, 1949, the City Council of the City of Riverside adopted Resolution No. 3709 declaring its intention to order the vacation of an alley, and fixing the time and place for hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 6300 et seq. of Part 3, Division 6 of the Streets and Highways Code of the State of California, and,

WHEREAS, said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside, and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and,

WHEREAS, on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested, and found, and hereby finds, from all of the evidence submitted that the alley hereinafter ordered vacated is unnecessary for present or prospective public use.

NOW, THEREFORE, it is RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the alley in the City of Riverside, County of Riverside, State of California, and described as follows:

That certain alley is, or was at one time, lying within Block "C" of Franklin Square, as shown by map on file in Book C, page 31 of Maps, Records of San Bernardino County, California,

is unnecessary for present or prospective public use, and that the same be and is hereby vacated.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this order, attested

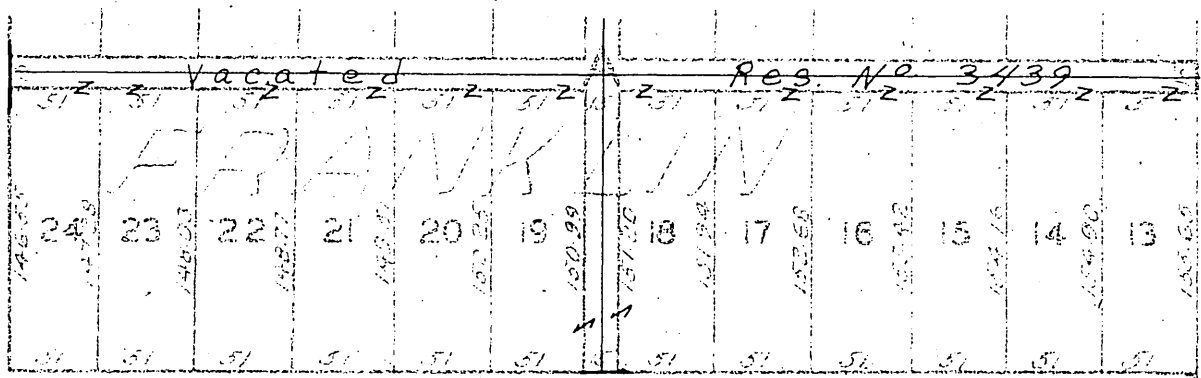

## SHOWING ALLEY TO BE VACATED

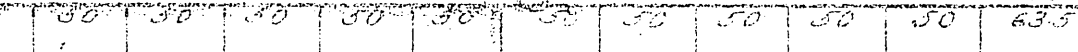
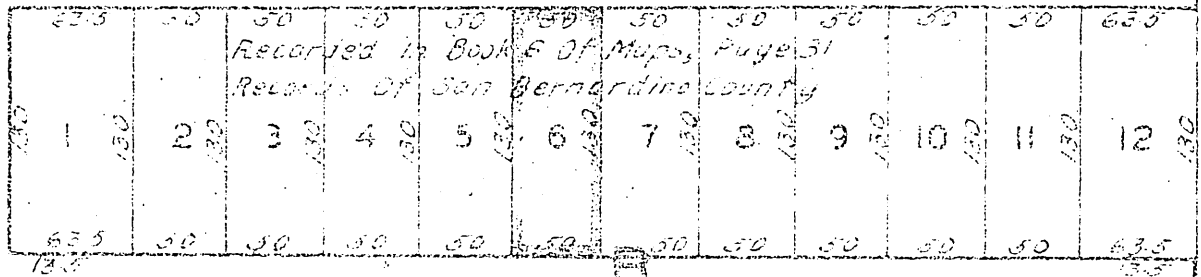

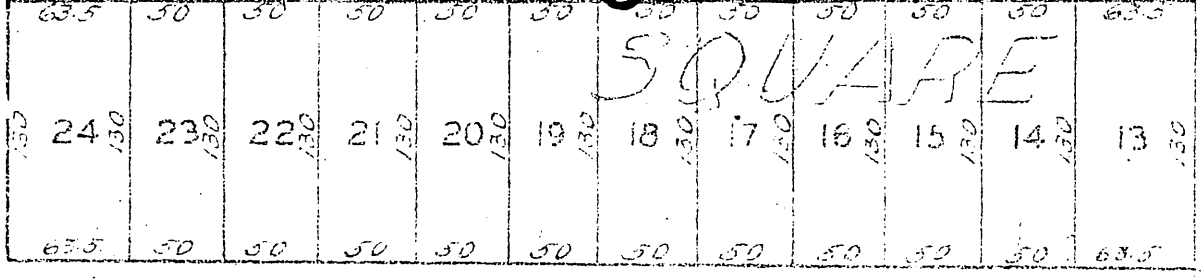
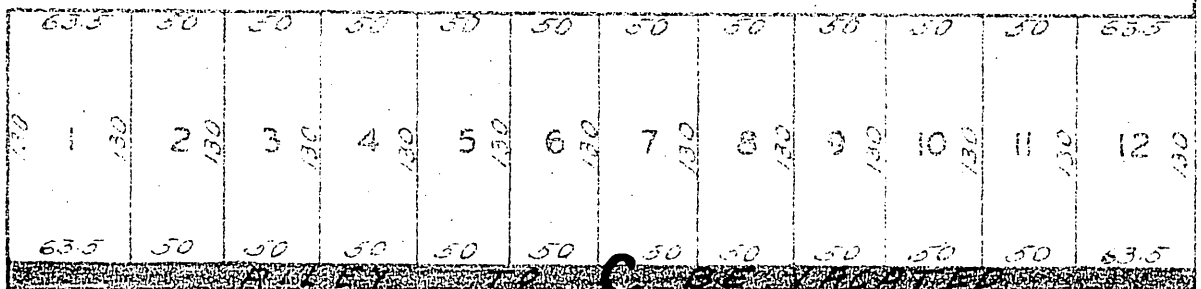
OTTAWA AVENUE
