A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A RIGHT OF WAY EASEMENT FOR DRAINAGE PURPOSES IN, OVER AND ACROSS PORTIONS OF LOTS 12 AND 13 IN BLOCK 3 OF LANDS OF THE RIVERSIDE LAND AND IRRIGATING COMPANY.

WHEREAS, it appears that the City of Riverside has an easement and right of way for drainage purposes in, over and across portions of Lots 12 and 13, in Block 3 of Lands of the Riverside Land and Irrigating Company, along the course herein-after described; and,

WHEREAS, it appears that said easement and right of way is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said easement and right of way for drainage purposes be and the same is hereby vacated. The said easement is situate in the City of Riverside, County of Riverside, State of California, and is described as follows:

A portion of that certain easement for open ditch, pipe line, flume or conduit for drainage purposes as conveyed to the City of Riverside by deed recorded August 15, 1899, in Book 83, page 230 of Deeds, Records of Riverside County, California, more particularly described as:

The southeasterly 10.00 feet of Lot 12 and the northwesterly 10.00 feet of Lot 13, of Block 3 of Lands of Riverside Land and Irrigating Company, as shown by map on file in Book 1, page 70 of Maps, Records of San Bernardino County, California;

Excepting therefrom the northeasterly 10.00 feet thereof.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.

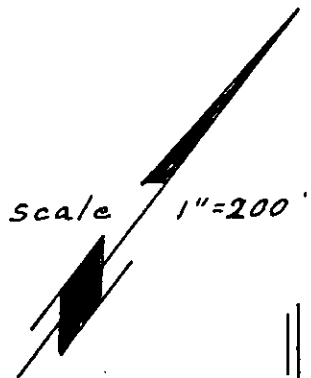
