RESOLUTION NO. 8793

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING AN ACCESS ROAD TO THE CITY QUARRY.

WHEREAS, on December 22, 1940, the City Council of the City of Riverside adopted Resolution No. 5771 declaring its intention to order the vacation of an access road to the City Quarry, and fixing the time and place for hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8500 et seq. of Part 3, Division 2 of the Streets and Highways Code of the State of California; and,

and whereas, said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside, and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and,

WHEREAS, on the day fixed for the hearing the City Council Board and considered the evidence offered by persons interested, and found and hereby finds from all of the evidence submitted that the access road to the City Quarry hereinafter ordered vacated is unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the said access road in the City of Riverside, County of Riverside, State of California, and described as follows:

All that portion of the Southeast quarter of Section 30, Township 2 South, Range 5 West, San Bernardino Base and Meridian, more particularly described as follows:

Commencing at the intersection of the center lines of Bronson Way and Glenhaven Avenue, formerly known as Victoria-Slainore Road, as shown on map of Fairview Estates, on file in Book 28, page 40 of Maps, Records of Riverside County, California; Thence South 89° 38' West, 40.62 feet to an angle point on the westerly line of said Glenhaven Avenue and the true point of beginning of the parcel to be described;

1 Thence North $39^{\circ} 44'$ West, 121.54 feet to a
2 tangent curve concave southerly, having a radius
of 305.20 feet;

3 Thence westerly along said curve to the left,
4 through an angle of $49^{\circ} 24'$, an arc length of 215.30
feet to an end thereof;

5 Thence tangent to said curve, South $49^{\circ} 52'$
West, 107.74 feet;

6 Thence South $48^{\circ} 46'$ East, 30.34 feet;

7 Thence North $47^{\circ} 52'$ East 103.17 feet to a tangent
curve concave southerly, having a radius of 275.20 feet;

8 Thence easterly along said curve to the right,
9 through an angle of $40^{\circ} 24'$, an arc length of 194.05
feet to an end thereof;

10 Thence tangent to said last mentioned curve South
11 $47^{\circ} 44'$ East, 131.73 feet to the westerly line of said
Glennaven Avenue;

12 Thence North $18^{\circ} 27'$ West, along said westerly
13 line, 31.00 feet to the true point of beginning;

14 Said portion hereinabove described being also that
15 certain strip of land, 30 feet in width, as conveyed to
16 the City of Riverside by deed recorded November 4, 1919,
17 in Book 110 of Deeds, at page 376 thereof, Records of
18 Riverside County, California;

19 is unnecessary for present or prospective public use, and that
20 the same be and is hereby vacated.

21 IT IS FURTHER ORDERED that the City Clerk of said City of
22 Riverside shall cause a certified copy of this order, attested
23 by the City Clerk under the seal of said City, to be recorded
24 in the office of the County Recorder of Riverside County,
25 California.
