A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A RIGHT OF WAY EASEMENT FOR PUBLIC UTILITY PURPOSES IN SUN GOLD TERRACE, UNIT NO.6.

WHEREAS, it appears that the City of Riverside has an easement and right of way for public utility purposes over a portion of Lot 425 in Sun Gold Terrace, Unit No.6, along the course hereinafter described; and,

WHEREAS, it appears that said easement and right of way is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said easement and right of way for public utility purposes be and the same is hereby vacated. That said easement is situate in the City of Riverside, County of Riverside, State of California, and described as follows:

The northeasterly ten (10.00) feet and the northerly ten (10.00) feet of Lot 425 of Sun Gold Terrace, Unit No.6, as shown by map on file in Book 25, page 68 of Maps, Records of Riverside County, California;

Excepting therefrom that portion lying northeasterly of a line parallel with and a perpendicular distance of ten (10.00) feet southwesterly of that line of said Lot 425 delineated as North 38° 01' 10" West, ten and 22/100 (10.22) feet on said map; said parallel line to terminate southeasterly on the southeasterly line of said Lot and northwesterly on the northeasterly line of said Lot.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.
