A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF A SANITARY SEWER EASEMENT IN BLOCK 10, RANGE 5, CITY OF RIVERSIDE.

WHEREAS it appears that the City of Riverside has a sanitary sewer easement in, over and across a portion of Block 10, Range 5, City of Riverside, along the course hereinafter described; and,

WHEREAS it appears that a portion of said sanitary sewer easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that a portion of said sanitary sewer easement be and the same is hereby vacated. The said portion of said sanitary sewer easement is situate in the City of Riverside, County of Riverside, State of California, and is described as follows:

The southerly 77.50 feet of that certain easement and right of way as conveyed to the City of Riverside by deed filed for record July 26, 1899, in Book 83, page 60 of Deeds, Records of Riverside County, California, said portion being more particularly described as follows:

Beginning at a point on the southerly line of Block 10, Range 5 of the Town of Riverside, as shown by map on file in Book 7, page 17 of Maps, records of San Bernardino County, California, said point bears westerly along said southerly line 165 feet from the southeast corner of said Block 10, Range 5; Thence northerly and parallel with the easterly line of said Block 10, Range 5, a distance of 77.50 feet to an end.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.

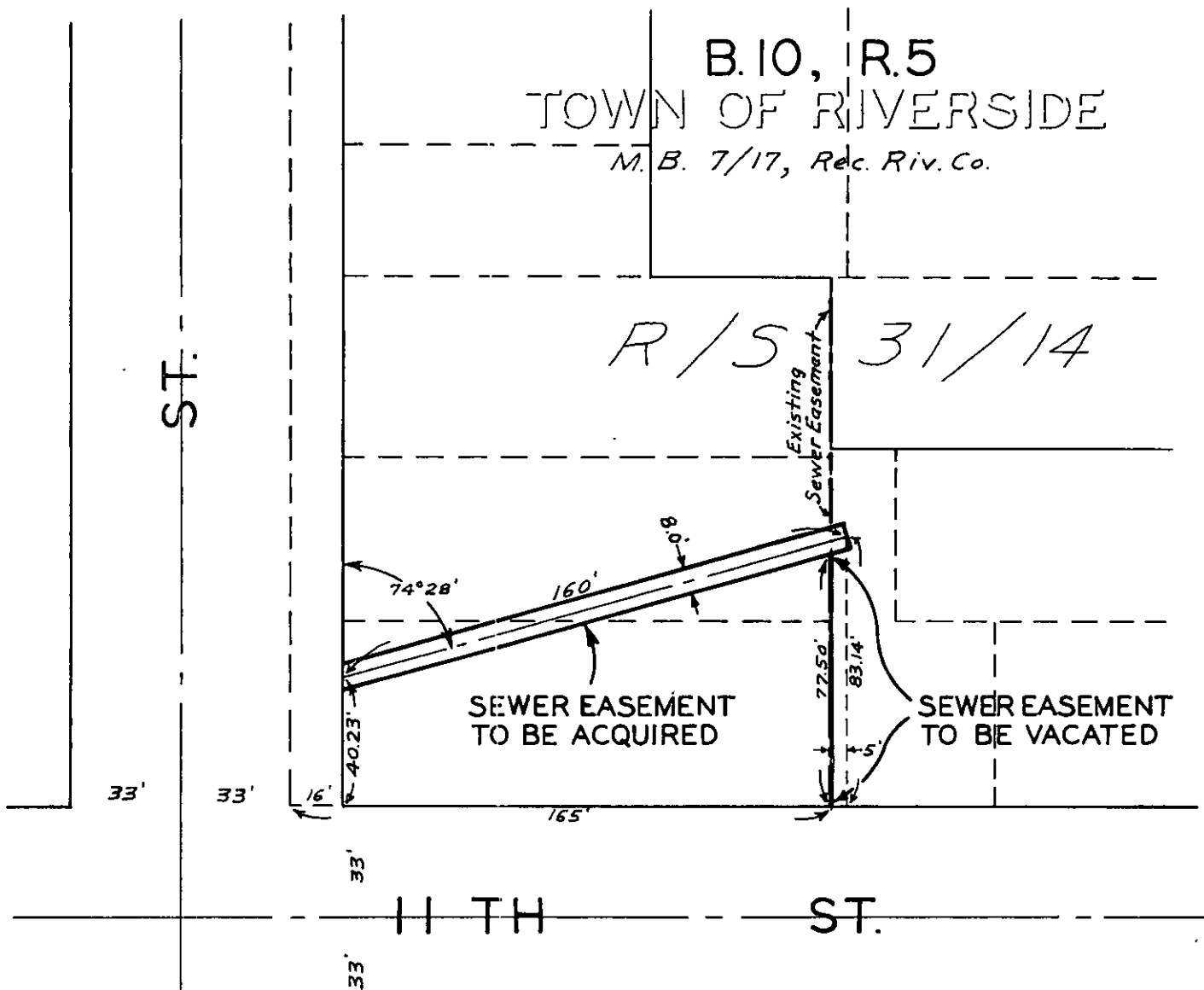

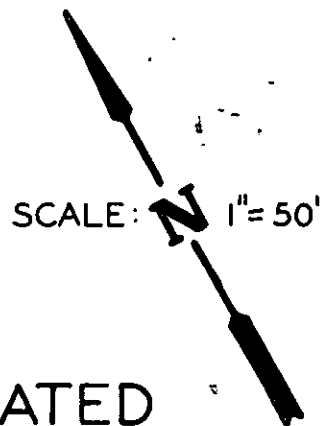
