A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF A DRAINAGE EASEMENT OVER AND ACROSS A PORTION OF LOT 11 IN BLOCK 7 OF LANDS OF THE RIVERSIDE LAND AND IRRIGATING COMPANY.

WHEREAS, it appears that the City of Riverside has a drainage easement in, over and across a portion of Lot 11 in Block 7 of lands of the Riverside Land and Irrigating Company, along the course hereinafter described; and,

WHEREAS, it appears that a portion of said drainage easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that a portion of said drainage easement be and the same is hereby vacated. The said portion of said drainage easement is situate in the City of Riverside, County of Riverside, State of California, and is described as follows:

A portion of that certain drainage easement 6 feet in width as conveyed to the City of Riverside by deed, and lying within Lot 11, Block 7 of Lands of Riverside Land and Irrigating Company, as shown by map on file in Book 1 of Maps, at page 70 thereof, Records of San Bernardino County, California, the center line of said portion to be vacated being more particularly described as follows:

Beginning at a point in the southerly line, 25 feet easterly from the southwesterly corner of said Lot 11 of said Block 7;

Thence northerly, parallel with the westerly line of said Lot 11, a distance of 330 feet;

Excepting therefrom the southerly 40 feet thereof.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.

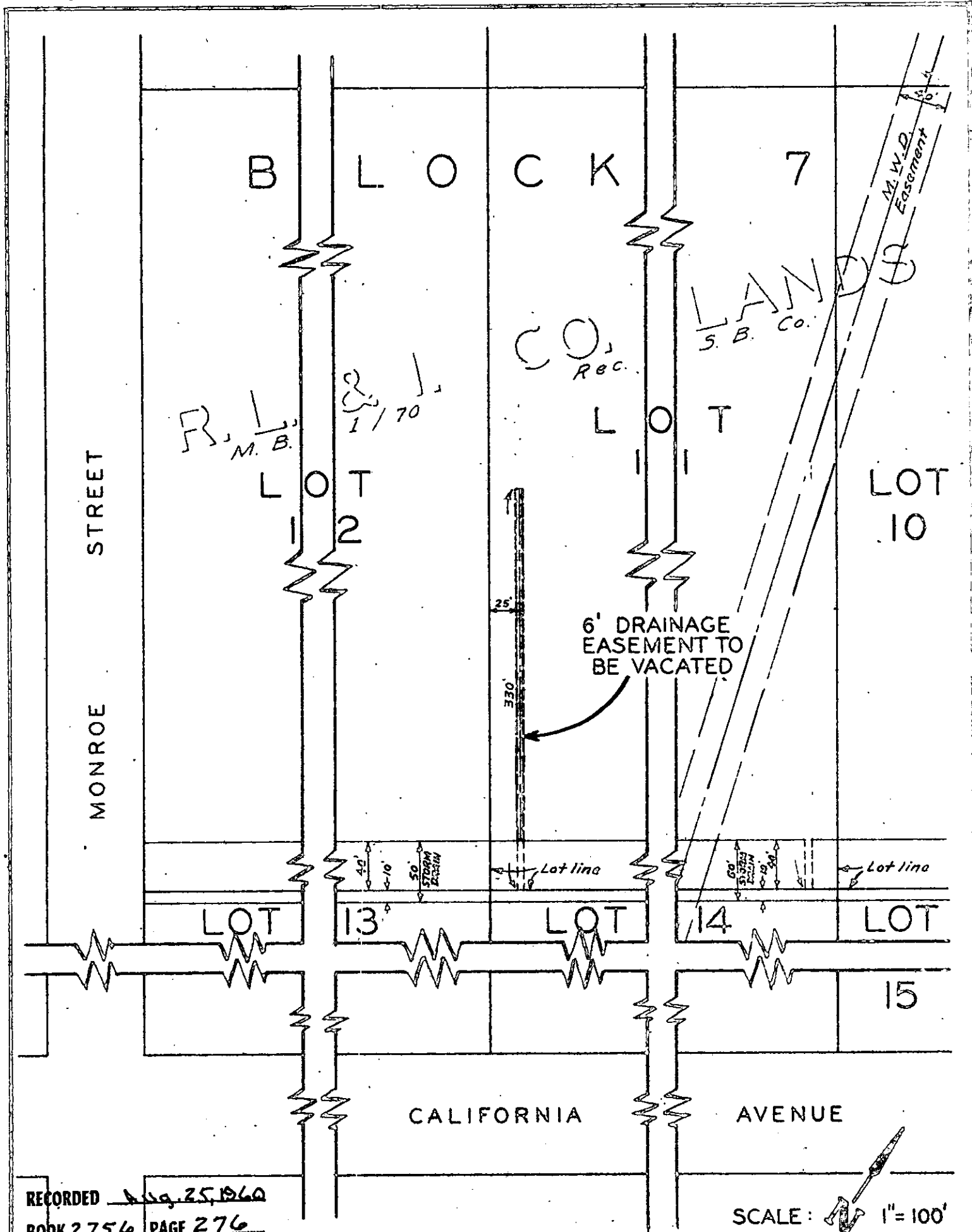
