RESOLUTION NO. 8978

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF A PORTION OF BENEDICT AVENUE TO CORNWALL AVENUE.

WHEREAS the Planning Commission of the City of Riverside has recommended and the City Council has determined that it is to the best interest of the City that the name of a portion of Benedict Avenue be changed;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the name of the hereinafter described portion of BENEDICT AVENUE be changed to CORNWALL AVENUE:

That portion of Benedict Avenue, formerly known as St. Lawrence Avenue, 40 feet in width, as shown on map of Church Subdivision on file in Book 6, page 55 of Maps, Records of Riverside County, California, contiguous with and immediately adjacent to the easterly lines of Lots 6 and 9 of said Church Subdivision.
