A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF A PUBLIC UTILITIES EASEMENT OVER AND ACROSS PORTIONS OF GREGORY SUBDIVISION.

WHEREAS it appears that the City of Riverside has a public utility easement in, over and across portions of Gregory Subdivision; and,

WHEREAS, it appears that a portion of said public utility easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that a portion of said public utility easement be and the same is hereby vacated. The said portion of said public utility easement is situate in the City of Riverside, County of Riverside, State of California, and is described as follows:

All that part of a dedicated public utility easement 10.0 feet in width in Gregory Subdivision as shown by map recorded in Map Book 32, page 14, Records of Riverside County, California, described as:

The southerly 5.0 feet of the northerly 10.0 feet of Lots 1, 2 and 3 of said Gregory Subdivision; All of the dedicated 10.0 foot public utility easement in Lot 4;

The northeasterly 5.0 feet of the southwesterly 10.0 feet of Lots 5, 6 and 7 of said Gregory Subdivision; All that part of the northwesterly or westerly one-half of the dedicated 10.0 foot public utility easement lying adjacent to, parallel with and northwesterly from, the southeasterly side of said Gregory Subdivision, covering a part of Lots 7, 8, 9, 10 and 11 and being a rectangular strip 5.0 feet in width parallel with said southeasterly side;

The southwesterly 5.0 feet of the northeasterly 10.0 feet of said Lot 11 of said Gregory Subdivision.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.

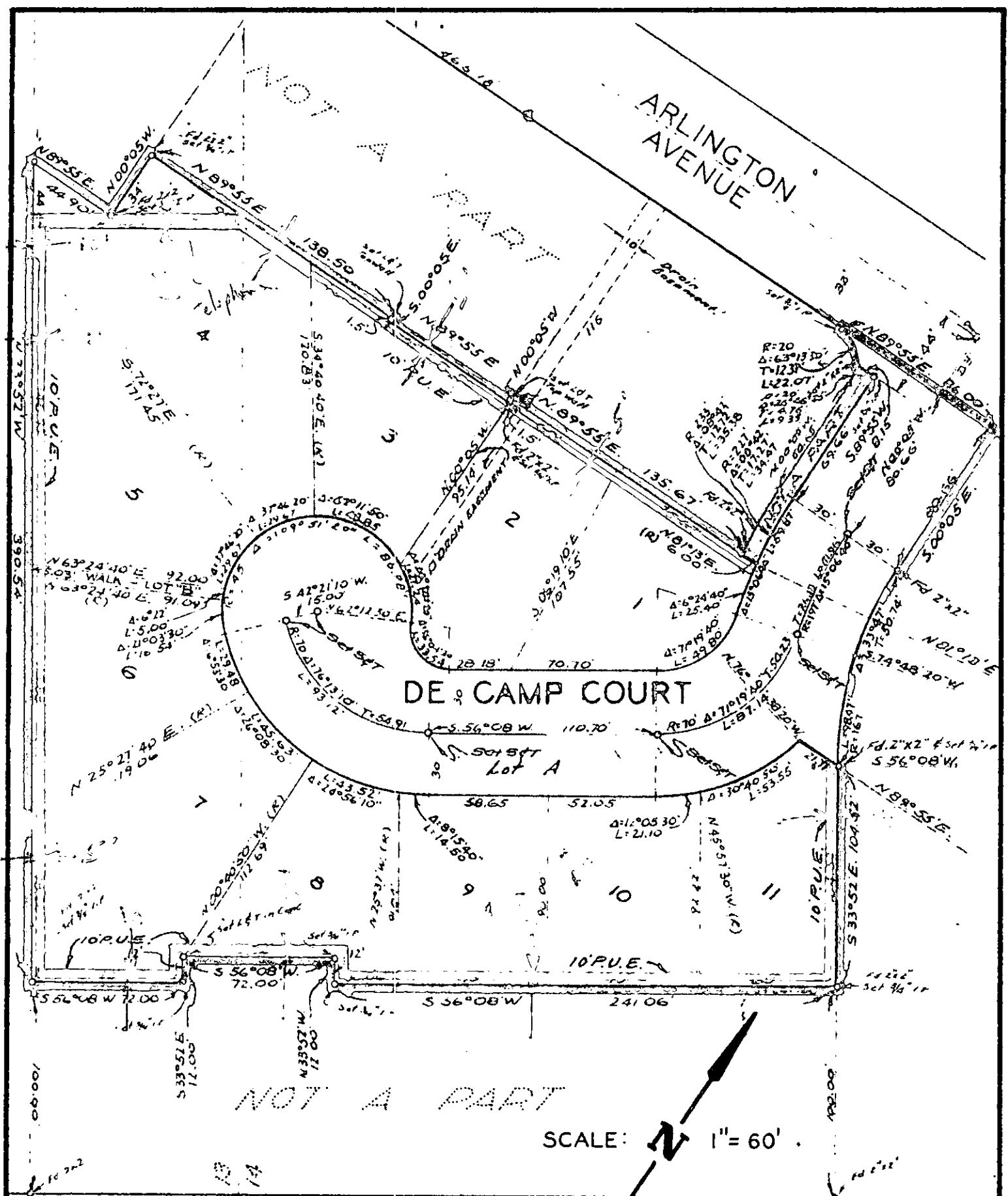
