2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING  
4 MARGORY STREET.

5 WHEREAS, on October 11, 1960, the City Council  
6 of the City of Riverside adopted Resolution No. 8979 declaring  
7 its intention to order the vacation of Margory Street, and fixing  
8 the time and place for hearing all persons interested in the  
9 proposed vacation, pursuant to the provisions of the Street  
10 Vacation Act of 1941, being Sections 8300 et seq. of Part 3,  
11 Division 9 of the Streets and Highways Code of the State of  
12 California; and

13 WHEREAS, said proposed vacation was submitted to and  
14 acted upon by the Planning Commission of the City of Riverside,  
15 and notice of hearing said resolution was given as provided by  
16 said Street Vacation Act of 1941; and,

17 WHEREAS, on the day fixed for the hearing the City  
18 Council heard and considered the evidence offered by persons  
19 interested and found, and hereby finds, from all of the  
20 evidence submitted that the street hereinafter ordered vacated  
21 is unnecessary for present or prospective use.

22 NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City  
23 Council of the City of Riverside, California, that the street  
24 located in the City of Riverside, County of Riverside, State of  
25 California, and described as follows:

26 Margory Street 30 feet in width as shown on map  
27 of McClaskey Tract No. 2 recorded in Book 14 of  
28 Maps, page 27, records of Riverside County,  
29 California; excepting that portion lying easterly  
30 of that certain strip of land conveyed to the  
31 United States of America recorded January 22, 1943,  
32 in Book 570, page 53, Official Records of said River-  
side County;

is unnecessary for present or prospective public use, and that  
the same be and is hereby vacated.

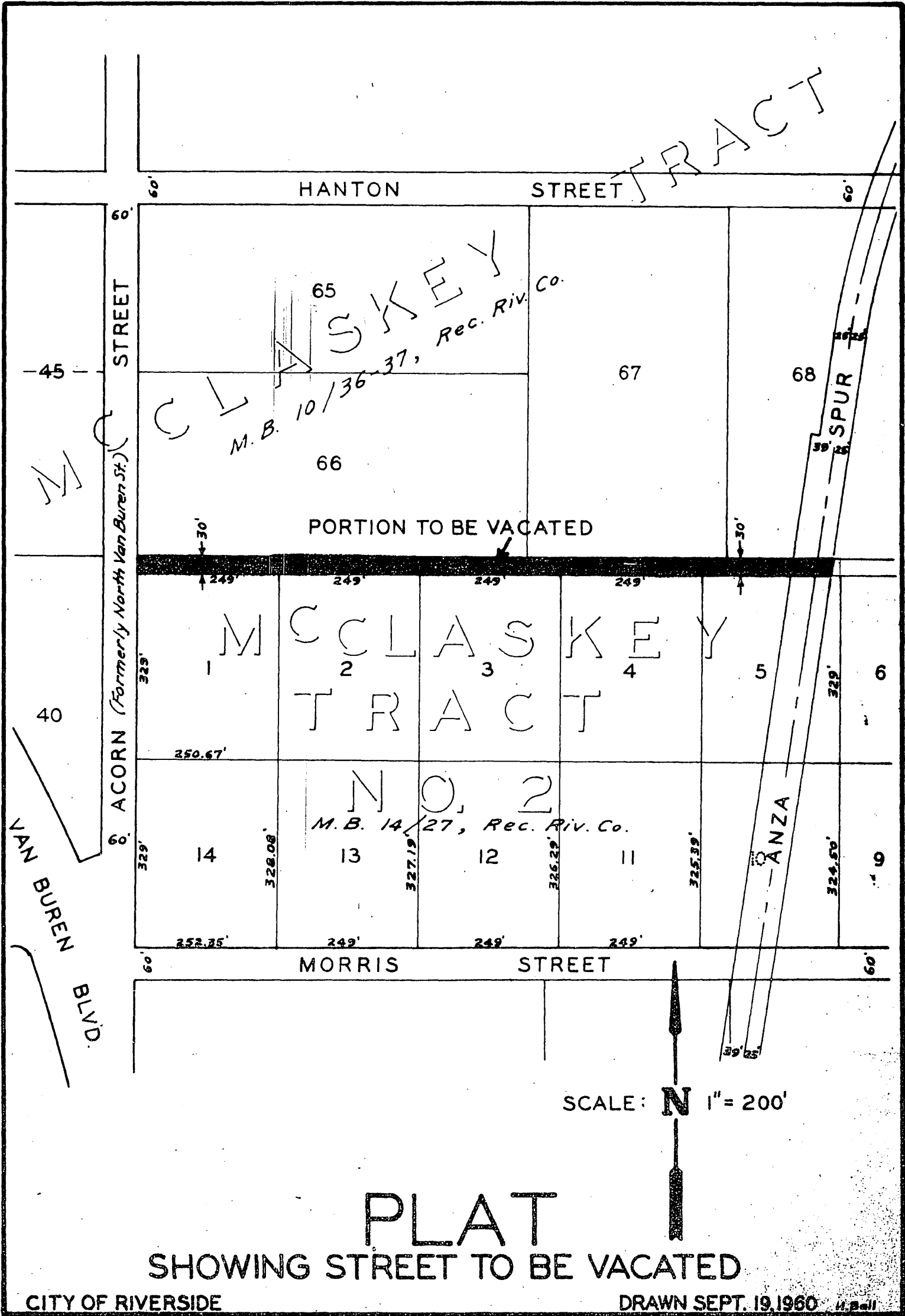
