RESOLUTION NO. 9027 DEPT OF PUBLIC WORKS

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING THE DEDICATION OF HOWE AVENUE AND BENEDICT AVENUE TO THE PUBLIC USE FOR STREET PURPOSES.

5 BE IT RESOLVED by the City Council of the City of River-
6 side:

7 That the herein described strips or parcels of land are
8 hereby accepted by the City of Riverside to the public use for
9 street purposes to become and to be known as Howe Avenue and
10 Benedict Avenue, respectively:

11 Said strips or parcels of land are located in the City of
12 Riverside, County of Riverside, State of California, and are des-
13 cribed as follows:

14 Those certain streets, 40 feet in width, as
15 shown on map of Church Subdivision on file in Book 6,
16 page 55 of Maps, Records of Riverside County, California,
more particularly described as follows:

17 FULMOR AVENUE, known known as Howe Avenue, and St.
18 Lawrence Avenue, a portion of said St. Lawrence Avenue
19 being now known as Cornwall Avenue and the remainder
of said St. Lawrence Avenue being now known as BENEDICT
AVENUE:

20 EXCEPTING therefrom those portions of St. Lawrence
21 Avenue, now known as Benedict Avenue, as vacated by
22 Resolution of the City Council of the City of Riverside,
a certified copy of which was recorded April 18, 1960,
in Book 2676, page 296 of Official Records, Records
of Riverside County, California;

23 ALSO EXCEPTING therefrom any portion of the herein-
24 above described streets previously accepted by the City
of Riverside.

25 The City Clerk is authorized and directed to cause a copy
26 of this resolution to be recorded by the County Recorder of River-
27 side County.
