

E A S E M E N T

THIS INDENTURE, made this 27th day of February 1961, by and between THE FIRST BAPTIST CHURCH OF RIVERSIDE, party of the first part, and the CITY OF RIVERSIDE, a Municipal Corporation, in the County of Riverside, State of California, party of the second part; WITNESSETH:

THAT in consideration of the sum of One Dollar lawful money of the United States to the party of the first part in hand paid by the party of the second part receipt whereon is hereby acknowledged. Said party of the first part does by these presents grant unto the party of the second part, its successors and assigns, a right-of-way and easement for the construction, maintenance, operation, inspection, and repair of a domestic water line and electric pole lines, and appurtenances for the operation of the City domestic water and electric systems in that certain property situated in the County of Riverside, State of California, described as follows:

That portion of Section 36, Township 2 South, Range 5 West, San Bernardino Base and Meridian.

The 50 feet lying southeasterly and adjacent to the Gage Canal right-of-way on bearings and distances described as follows:

Starting at the east line of the Gage Canal right-of-way and the northeasterly property line of Alessandro Road, as shown in Book 20, page 22 of Records of Surveys, record of Riverside County, California. Thence north $86^{\circ} 52' 05''$ east, a distance of 61.19 feet; thence north $68^{\circ} 33' 15''$ east, a distance of 80.01 feet; thence north $55^{\circ} 45' 55''$ east, a distance of 70.02 feet; thence north $47^{\circ} 07' 55''$ east, a distance of 42.32 feet, being a total of 253.54 feet.

TOGETHER WITH the right of entry upon said premises over and across which said easement and right-of-way is granted for the purpose of installing, maintaining and repairing said domestic water and

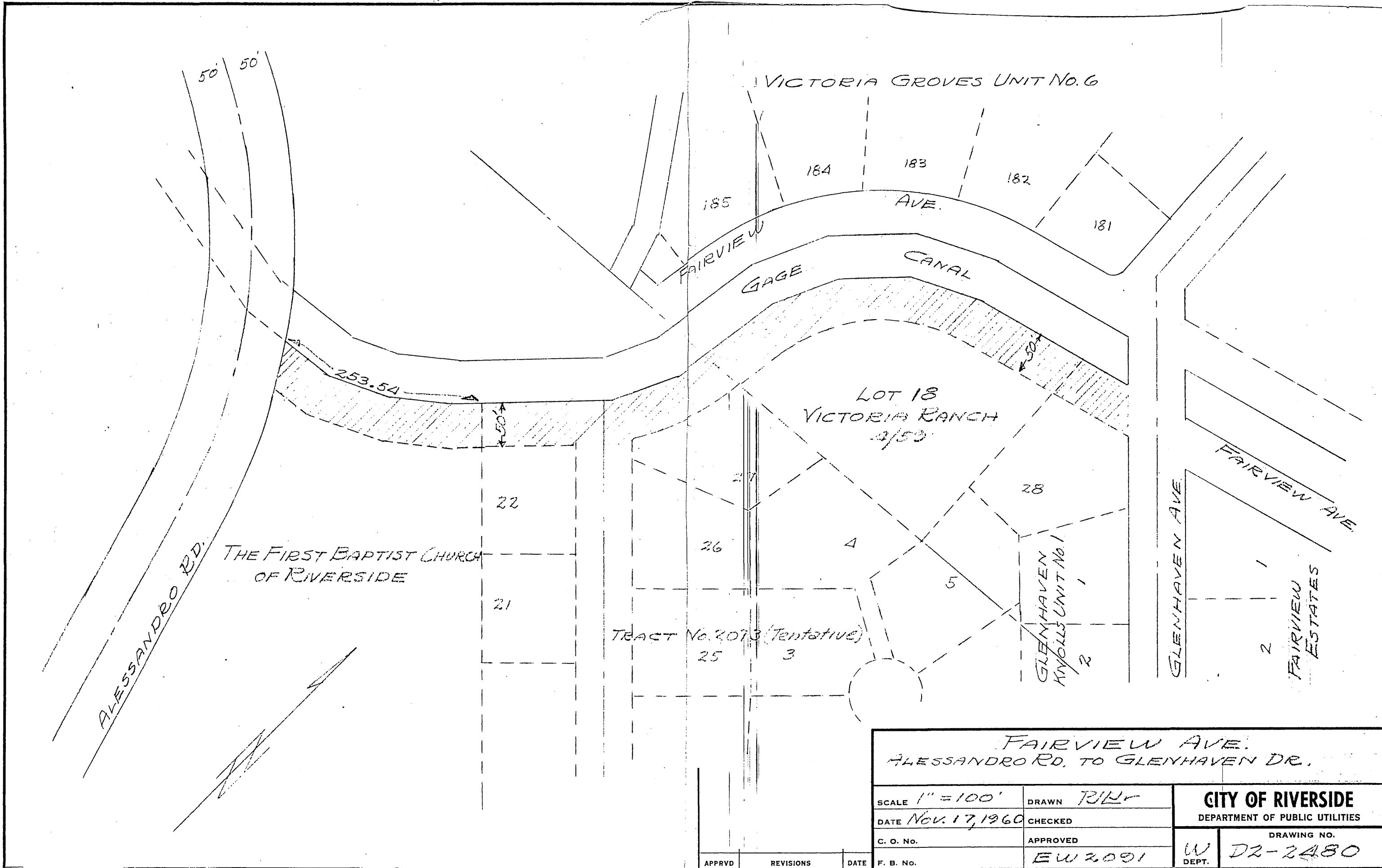
