RESOLUTION NO. 9109

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF A PUBLIC UTILITY EASEMENT OVER AND ACROSS LOT 40 OF NON-RESIDENTIAL "M-2" GENERAL MANUFACTURING SUBDIVISION NO. M-12, UNIT NO. 2, AND RESERVING AN AERIAL EASEMENT ONLY OVER SAID VACATED PORTION OF SAID PUBLIC UTILITY EASEMENT.

WHEREAS, it appears that the City of Riverside has a public utility easement in, over and across Lot 40 of Non-Residential "M-2" General Manufacturing Subdivision No. M-12, Unit No. 2; and,

WHEREAS, it appears that a portion of said public utility easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that a portion of said public utility easement be and the same is hereby vacated. The said portion of said public utility easement is situate in the City of Riverside, County of Riverside, State of California, and described as:

A public utility easement in, over and across all of the north ten feet, excepting the westerly ten feet, of Lot 40 of Non-Residential "M-2" General Manufacturing Subdivision No. M-12, Unit No. 2, as shown by map recorded in Book 34, page 38 of Maps, Records of Riverside County, California; excepting and reserving an aerial easement only, with a minimum ground clearance of 25 feet, in, over and across said vacated portion of said easement.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.
