RESOLUTION NO. 9072

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF A PORTION OF HUGHES ALLEY TO SARATOGA STREET, CHANGING THE NAME OF MISSION STREET TO MASON STREET, AND CHANGING THE NAME OF A PORTION OF INDIANA AVENUE TO UBRUN PLACE.

BE IT RESOLVED by the City Council of the City of Riverside, California that, pursuant to the recommendation of the Planning Commission of the City of Riverside, the name of the hereinafter described portion of HUGHES ALLEY be changed to SARATOGA STREET:

That portion of Hughes Alley, 20 feet in width, lying southerly of the right-of-way of the Atcheson, Topeka and Santa Fe Railway Company and northerly of Fox Street;

Excepting therefrom the northerly 102.07 feet as measured parallel with the right-of-way of the Atcheson, Topeka and Santa Fe Railway Company.

BE IT FURTHER RESOLVED that, pursuant to the recommendation of the Planning Commission of the City of Riverside, the name of the hereinafter described MISSION STREET be changed to MASON STREET:

Mission Street as shown on map of Re-subdivision of Van Buren Park on file in Book 8, page 26 of Maps, Records of Riverside County, California.

BE IT FURTHER RESOLVED THAT, pursuant to the recommendation of the Planning Commission of the City of Riverside, the name of the hereinafter described portion of INDIANA AVENUE be changed to UBRUN PLACE:

All that part of Indiana Avenue 80 feet in width lying adjacent to the northwesterly line of Lots 1 and 2, Block 37 of the Lands of the Riverside Land and Irrigating Company, as shown on map recorded in Book 1, page 70, Records of San Bernardino County, California, which lies southwesterly of the southwesterly line of Tyler Street, 80.0 feet in width, and northeasterly of the northerly right-of-way line of the Atcheson, Topeka and Santa Fe Railway Company right-of-way.
