BE IT RESOLVED by the City Council of the City of Riverside, California, that pursuant to the recommendation of the Planning Commission of the City of Riverside, the name of the hereinafter described SOUTH STREET be changed to LE CONTE DRIVE:

That certain street, of variable width, running easterly along the southerly line of Section 30 and/or the northerly line of Section 31, Township 2 South, Range 4 West, San Bernardino Base and Meridian; the easterly terminus of said street being 370 feet easterly of The Gage Canal, and the westerly terminus being the easterly line of Chicago Avenue.
