A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING STREET NAMES.

WHEREAS the Planning Commission of the City of Riverside has recommended and the City Council has determined that it is to the best interests of the City that the names of the herein-after designated streets be changed:

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the name of the hereinafter described portion of BLAINE STREET be changed to THIRD STREET:

All that part of that certain street known as Blaine Street, the center line of said Blaine Street being the east-west center line of Section 19, Township 2 South, Range 4 West, San Bernardino Base and Meridian, as the same now exists from the easterly line of Chicago Avenue in an easterly direction to the south-westerly line of the proposed State of California Freeway VIII-RIV-19-RIV.B.

BE IT FURTHER RESOLVED that, pursuant to the recommendation of the Planning Commission of the City of Riverside, the name of the hereinafter described portion of BENEDICT AVENUE be changed to HOWE AVENUE:

All that part of the street known as Benedict Avenue, formerly known as St. Lawrence Avenue, as the same now exists along the southerly and/or southeasterly lines of Lots 1 and 2 and along the northwesterly line of Lot 7 of Church Subdivision as shown on map on file in Book 6, page 55 of Maps, Records of Riverside County, California, extending from the easterly terminus of the presently located Howe Avenue, formerly known as Fulmore Avenue, in a northerly and northeasterly direction to an end in the east line of Section 36, Township 2 South, Range 5 West, San Bernardino Base and Meridian.

BE IT FURTHER RESOLVED THAT, pursuant to the recommendation of the Planning Commission of the City of Riverside, the name of the hereinafter described DRUMMOND STREET be changed to DRUMMOND DRIVE:

All of Lot "F" of Victoria Groves Unit No. 6 as shown on map on file in Book 37, page 87 of Maps, Records of Riverside County, California.

BE IT FURTHER RESOLVED that, pursuant to the recommendation of the Planning Commission of the City of Riverside, the name of the hereinafter described VALENCIA STREET and VALENCIA DRIVE be changed to VALENCIA HILL DRIVE:

All of Lot "A" of Sun Gold Highlands No. 1, as shown on map on file in Book 32, at page 80 of Maps, Records of Riverside County, California;

Also including all of Lot "B" of University Hills No. 1, as shown on map on file in Book 34, at page 72 of Maps, Records of Riverside County, California.

Also including all of the easterly 30.0 feet of the southwest quarter of the southeast quarter of Section 20, Township 2 South, Range 4 West, San Bernardino Base and Meridian lying southerly of Watkins Drive.

Also including that certain street known as Valencia Drive in the south half of the northeast quarter of Section 20, Township 2 South, Range 4 West, San Bernardino Base and Meridian, and being all of the westerly 30.0 feet of the southeast quarter of said northeast quarter and all of the easterly 30.0 feet of the southwest quarter of the said northeast quarter lying southerly of the south line of Massachusetts Avenue and northerly of the north line of Blaine Street in said Section 20.
