A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING THE DEDICATION OF A PORTION OF LINDEN STREET TO PUBLIC USE FOR STREET PURPOSES .

BE IT RESOLVED by the City Council of the City of Riverside:

That the herein described strip or parcel of land is hereby accepted by the City of Riverside to the public use for street purposes to become and to be known as a portion of Linden Street.

Said strip or parcel of land is located in the City of Riverside, County of Riverside, State of California, and is described as follows:

A strip of land 11.0 feet in width in a part of Lot 54 of the Lands of the East Riverside Land Company in a part of Section 19, Township 2 South, Range 4 West, San Bernardino Base and Meridian, as shown on map on file in Book 6 , page 44 of Maps, Records of San Bernardino County, California, described as follows:

All of the northerly 11.0 feet of the easterly 198.0 feet of the westerly 231.0 feet of said Lot 54.

The City Clerk is authorized and directed to cause a certified copy of this resolution to be recorded by the County Recorder of Riverside County.
