

RESOLUTION NO. 9323

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING STREET NAMES.

WHEREAS, the Planning Commission of the City of Riverside has recommended and the City Council has determined that it is to the best interests of the City that the names of the hereinafter designated streets be changed;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the names of the hereinafter designated streets are changed as follows:

CREST WAY:

That certain street of variable width known as Crest Way, described as follows:

All of Lot "A" of Rockledge Park No.2, as shown by map on file in Book 19, page 92 of Maps, Records of Riverside County, California;

Also including all of Lot "C" of Rockledge Park No.3 as shown on map on file in Book 21, page 1 of Maps, Records of Riverside County, California,

be changed to ROCKHILL WAY.

CYPRESS AVENUE:

All of that certain street 40.0 feet in width in a part of Lots 4, 5, 153 and 154 of the lands of the Southern California Colony Association, as shown on map on file in Book 7, page 3 of Maps, Records of San Bernardino County, California, described as follows:

All that part of the southeasterly 20.0 feet of said Lots 5 and 154 and all that part of the northwesterly 20.0 feet of Lots 4 and 153 of the said Southern California Colony Association Lands which lies southerly of the southeasterly line of Magnolia Avenue and northerly of the northwesterly line of the now vacated Emma Street as said vacated Emma Street is shown on map of Prospect Place on file in Book 5, page 88 of Maps, Records of San Bernardino County, California,

be changed to STADIUM AVENUE.

CROWELL STREET:
