A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING STREET NAMES.

WHEREAS, the Planning Commission of the City of Riverside has recommended and the City Council has determined that it is to the best interests of the City that the names of the hereinafter designated streets be changed;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the names of the hereinafter designated streets are changed as follows:

CORBIN ROAD

All that certain street 60.0 feet in width known as Corbin Road being all of Lot "K" of University Hills Unit No.3, as shown on map on file in Book 35, at page 69 of Maps, Records of Riverside County, California,

DEL FERN COURT

All of that certain street 60.0 feet in width known as Del Fern Court being all of Lot "A" of California Estates, as shown on map on file in Book 26, at page 100 of Maps, Records of Riverside County, California,

be changed to DEGHER COURT.

LA FERN CIRCLE

All that certain street of variable width known as La Fern Circle, being all of Lot "B" of Hampshire Subdivision as shown on map on file in Book 34, page 78 of Maps, Records of Riverside County, California,

PEDLEY ROAD

All that part of that certain street known as Pedley Road 80.0 feet in width, lying southerly and westerly of the southwesterly right of way line of Van Buren Boulevard as now located.
