

RESOLUTION NO. 9393

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, NAMING A NEW PORTION OF A STREET AND CHANGING THE NAMES OF CERTAIN STREETS.

BE IT RESOLVED by the City Council of the City of Riverside, California, that pursuant to the recommendation of the Planning Commission of the City of Riverside

All that certain street of variable width, in a part of the South-half of Section 36, Township 2 South, Range 5 West, S.B.B. & M. now existing between the west end of Benedict Avenue and the northeasterly line of Alessandro Boulevard,

be named GLENHAVEN AVENUE.

BE IT FURTHER RESOLVED that pursuant to the recommendation of the Planning Commission of the City of Riverside that the names of the hereinafter designated streets are changed as follows:

DOWNS AVENUE

All of that certain avenue of variable width, known as Downs Avenue, being all of Lot "A" of Arlanza Downs Subdivision Unit No. 1, as shown on map on file in Book 29, at page 49 of Maps, Records of Riverside County, California,


be changed to VIA NORTE DRIVE.

GLENHAVEN AVENUE

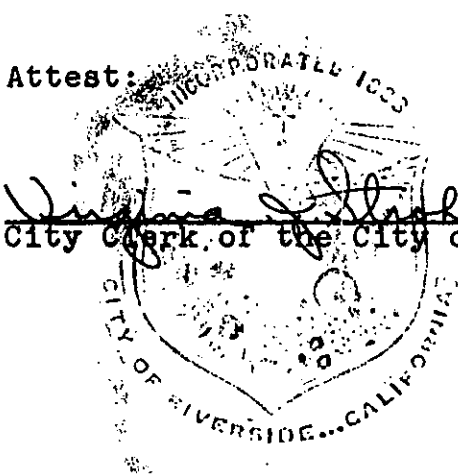
All that certain street now known as Glenhaven Avenue, being that portion of Lot A Victoria Woods Unit No.1 as shown on map on file in Book 6, at page 55 of Maps, Records of Riverside County, California, lying along the westerly side of Lots 1, 2, 3, 4, 5 and 6 of said Victoria Woods Unit No.1,

be changed to GLENHAVEN COURT.
