
The City Clerk is authorized and directed to cause a certified copy of this resolution to be recorded by the County Recorder of Riverside County.

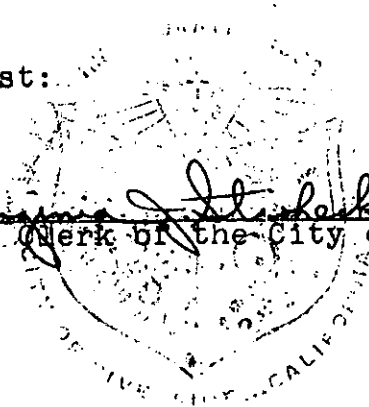

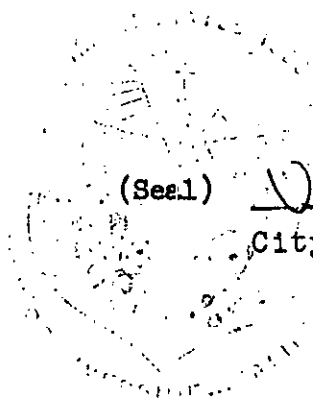

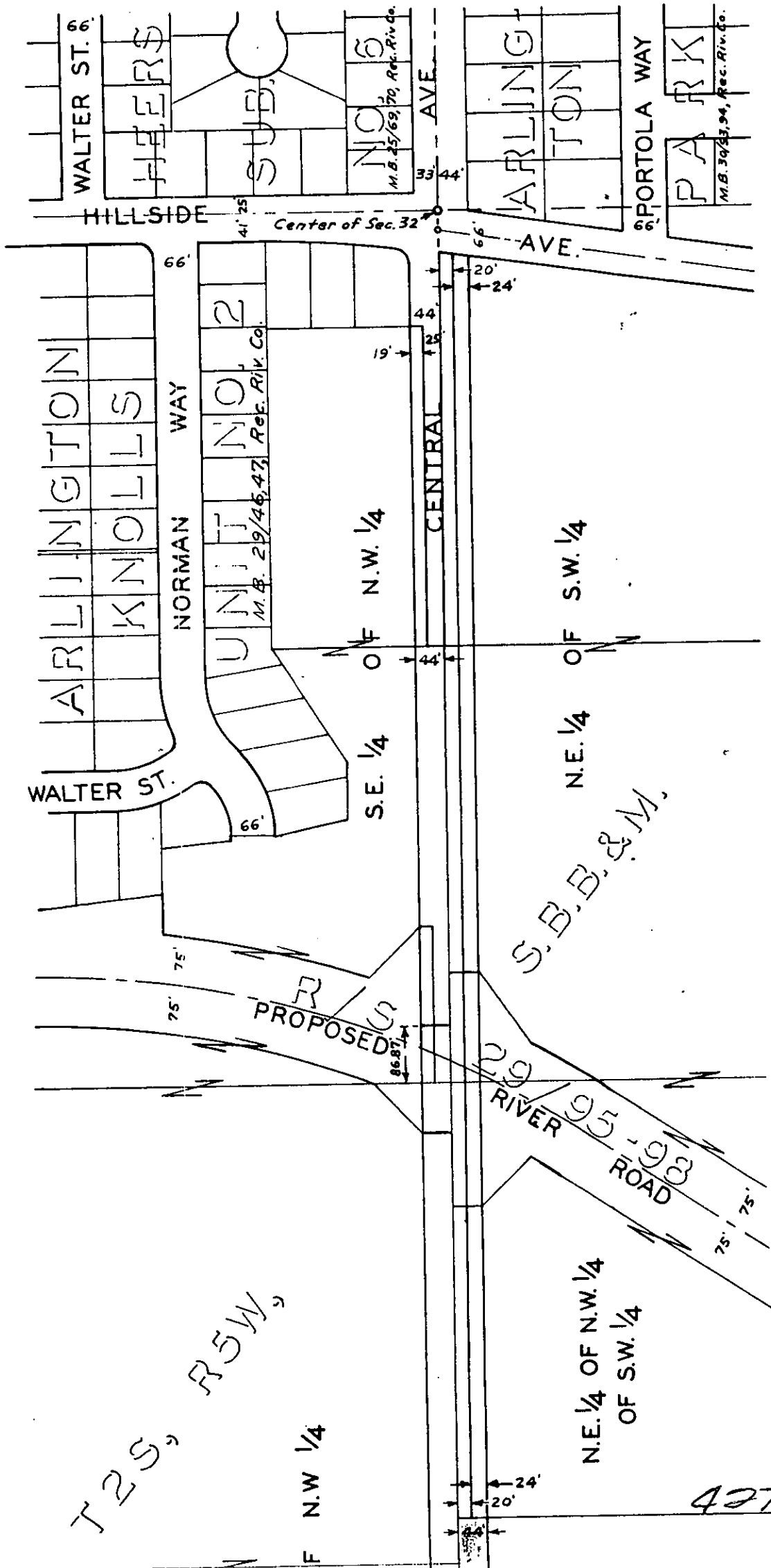
