On motion of Supervisor _____, seconded by Supervisor _____, and duly carried, the following resolution was adopted:

BE IT RESOLVED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled this 6th day of July, 1954, that the following described strip of land (so necessary to the public convenience as a public highway and is hereby declared open for use by the public as a county highway, to be known as Pedley Dump Road; said real property is described as follows:

All that portion of Lots 15 and 16 as shown on Map of the McCluskey Tract filed in Book 10, pages 36 and 37 of Maps; all those portions of Lots 7 and 8, as shown on Map of the Randolph Subdivision, filed in Book 16, page 39 of Maps; and all that portion of Tract 4 as shown on Map of the River Farm Tract, filed in Book 7, page 52 of Maps, all being records of Riverside County, more particularly described as follows:

Commencing at Engineers' Station 110+52.30 on the center line of the Arlington-Mira Loma Road as approved by the State of California on April 12, 1954; Thence S.79°51' West, a distance of 39 feet to the point of beginning; Thence S.49°40'25" East, a distance of 471.44 feet; thence S.40°35' East, a distance of 126.59 feet; thence S.40°25' East, a distance of 50.71 feet to the westerly line of Pedley Road; thence S.17°34'25" East, along said westerly line of Pedley Road, a distance of 213.35 feet; thence N.37°13'15" West, a distance of 288.50 feet; thence S.49°40'25" West, a distance of 606.43 feet;

Thence N.79°51' East, a distance of 90.9 feet to the point of beginning.
BE IT FURTHER RESOLVED, that the Clerk of the Board be and he is hereby authorized and directed to cause a certified copy of this Resolution to be recorded in the Office of the County Recorder of the County of Riverside, State of California.
