hereby GRANT(S) to WILLIAM J. THOMPSON and EVELYN I. THOMPSON,  
husband and wife,

AS JOINT TENANTS,

the following described real property in the state of California, county of Riverside:

Lot 237 and all that portion of Lot 238 of CAMP ANZA  
SUBDIVISION NO. 1, as shown by Map on file in Book 22 pages 81 and  
82 of Maps, records of Riverside County, California, particularly  
described as follows:

Beginning at the Northeastly corner of said Lot 238;  
Thence Westerly along the Northerly line of said Lot 238, a  
distance of 25 feet;
