

RESOLUTION ABANDONING COUNTY HIGHWAY

1 WHEREAS, a proposal to abandon a portion of each of two
2 county highways known as McKinley Avenue and Canyon Crest Road in
3 the 3rd Road District, as hereinafter described, was filed with the
4 Board of Supervisors, and due and legal notice of a public hearing
5 having been given as required by law, and the report of the Plan-
6 ning Commission having been made and filed, and all interested
7 persons having been heard, now, therefore,

8 BE IT RESOLVED, FOUND, DETERMINED AND ORDERED by the
9 Board of Supervisors of the County of Riverside, State of California,
10 in regular session assembled on November 10, 1958, that a portion
11 of each of the county highways known as McKinley Street and Canyon
12 Crest Road, and hereinafter described, is unnecessary for present
13 or prospective public use, and all right therein is hereby aban-
14 doned, reserving and excepting the easement and right of way therein
15 for existing electric power transmission and pole line and for one
16 existing gas pipeline, both in McKinley Avenue, pursuant to Section
17 959.1 of the Streets and Highways Code, said abandonment being in
18 the County of Riverside, State of California, and described as
19 follows:

20 McKINLEY AVENUE

21 The portion of McKinley Avenue between the
22 easterly prolongation of the northerly line of Lot 3
23 in Block 1 and the easterly prolongation of the
24 northerly line of Lot 6 in Block 1, as shown on Map of
25 the Subdivision of Section 30, Township 2 South,
26 Range 4 West, S.B.S. & M., filed in Book 2, Page 37
27 of Maps, Riverside County records.

28 CANYON CREST ROAD

29 That portion of Canyon Crest Road, 60 feet wide,
30 in Sections 29 and 30, Township 2 South, Range 4 West,
31 S.B.S. & M., according to Government Survey, described
32 as follows:

Beginning at the Southeast corner of Lot 3 of Box Spring Orange Tract, as shown by Map on file in Book 5 of Maps, Page 180, Records of said County; thence along the South line of said Lot 3, North 89° 55'13" West 12.29 feet; thence South 33°48'43" East 75.99 feet to the East line of said Canyon Crest Road; thence along said East line North 00°00'07" East 15.84 feet; thence North 39°07'58" West 47.53 feet to the common line between said Sections 29 and 30, distant along said common line South 00°00'07" West 10.41 feet from the Point of Beginning; thence along said common line North 00°00'07" East 10.41 feet to the Point of Beginning.

Containing 0.01 of an acre, more or less.
