A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF A PUBLIC UTILITIES EASEMENT IN A PORTION OF LOT A OF EL PADRO ACRES.

WHEREAS, it appears that the City has a public utilities easement over and across a portion of Lot A of El Padro Acres;

8 WHEREAS, it appears that said easement is no longer
9 necessary for present or prospective public use;

10 NOW, THEREFORE, IT IS ORDERED by the City Council of
11 the City of Riverside, California, that said easement be and
12 the same is hereby vacated. The said easement is situate in
13 the City of Riverside, County of Riverside, State of California,
14 and is described as follows:

15 A 10.0 foot public utilities easement over and
16 across Lot A of El Padro Acres, as shown by map
17 on file in Book 11, page 27 of Maps, Records of
18 Riverside County, California, described as follows:

19 The westerly 10.0 feet of said Lot A;
20 EXCEPT the south 40.0 feet thereof.
21 RESERVING THEREFROM all rights and easements
22 acquired by the City of Riverside from the Riverside
23 Water Company.

24 IT IS FURTHER ORDERED that the City Clerk of said City
25 of Riverside shall cause a certified copy of this resolution
26 and order, attested by the City Clerk under the seal of said
27 City, to be recorded in the office of the County Recorder of
28 Riverside County, California.
