

1 RESOLUTION NO. 9540

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING
4 PUBLIC UTILITIES EASEMENTS IN LOTS 11, 12, 13
AND 14 OF NON-RESIDENTIAL "M-2" GENERAL
MANUFACTURING SUBDIVISION NO. M-12.

5 WHEREAS, it appears that the City of Riverside has public
6 utilities easements over and across Lots 11, 12, 13 and 14 of
7 Non-Residential "M-2" General Manufacturing Subdivision No.M-12;
8 and,

9 WHEREAS, it appears that said easements are no longer
10 necessary for present or prospective public use;

11 NOW, THEREFORE, IT IS ORDERED by the City Council of the
12 City of Riverside, California, that said easements be and the
13 same are hereby vacated. The said easements are situate in the
14 City of Riverside, County of Riverside, State of California,
15 and are described as follows:

16 Those certain easements designated as "5' Public
17 Utility Easement" as shown on map of Non-Residential
18 "M-2" General Manufacturing Subdivision No.M-12
on file in Book 34, page 38 of Maps, Records of
Riverside County, California, described as follows:

19 Parcel 1

20 That certain easement designated as "5' Public
21 Utility Easement" lying over and upon the easterly
5 feet of Lot 14 of said subdivision.

22 Parcel 2

23 That certain easement designated as "5' Public
24 Utility Easement" lying over and upon the westerly
5 feet of Lots 11, 12 and 13 of said subdivision.

25 IT IS FURTHER ORDERED that the City Clerk of said City
26 of Riverside shall cause a certified copy of this resolution
27 and order, attested by the City Clerk under the seal of said
28 City, to be recorded in the office of the County Recorder of
Riverside County, California.
