RESOLUTION NO. 9551

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING PORTIONS OF SEWER EASEMENTS IN LOTS 6 AND 7 OF TRACT 2175.

6 WHEREAS, it appears that the City of Riverside has
 7 sewer easements over and across Lots 6 and 7 of Tract 2175; and
 8 WHEREAS, it appears that portions of said easements are
 9 no longer necessary for present or prospective public use;
 10 NOW, THEREFORE, IT IS ORDERED by the City Council of
 11 the City of Riverside, California, that said portions of said
 12 sewer easements be and the same are hereby vacated. The said
 13 portions of easements are situate in the City of Riverside,
 14 County of Riverside, State of California, and are described as
 15 follows:

16 All that certain easement designated as "9.25'
 17 Sewer Easement" and also designated as "9.75' Sewer
 18 Easement" and lying within Lot 6 of Tract 2175, as
 19 shown on plat on file in Book 41, pages 45 and 46
 20 of Maps, Records of Riverside County, California;

21 TOGETHER with that certain easement designated as
 22 "Sewer Easement" lying within the most northerly
 23 portion of Lot 7 of said Tract 2175.

24 EXCEPT from said easement lying within said Lot 6
 25 the northeasterly 244.50 feet thereof, said north-
 26 easterly 244.50 feet being measured along the south-
 27 easterly line of said easement.

28 IT IS FURTHER ORDERED that the City Clerk of said City
 29 of Riverside shall cause a certified copy of this resolution
 30 and order, attested by the City Clerk under the seal of said
 31 City, to be recorded in the office of the County Recorder of
 32 Riverside County, California.

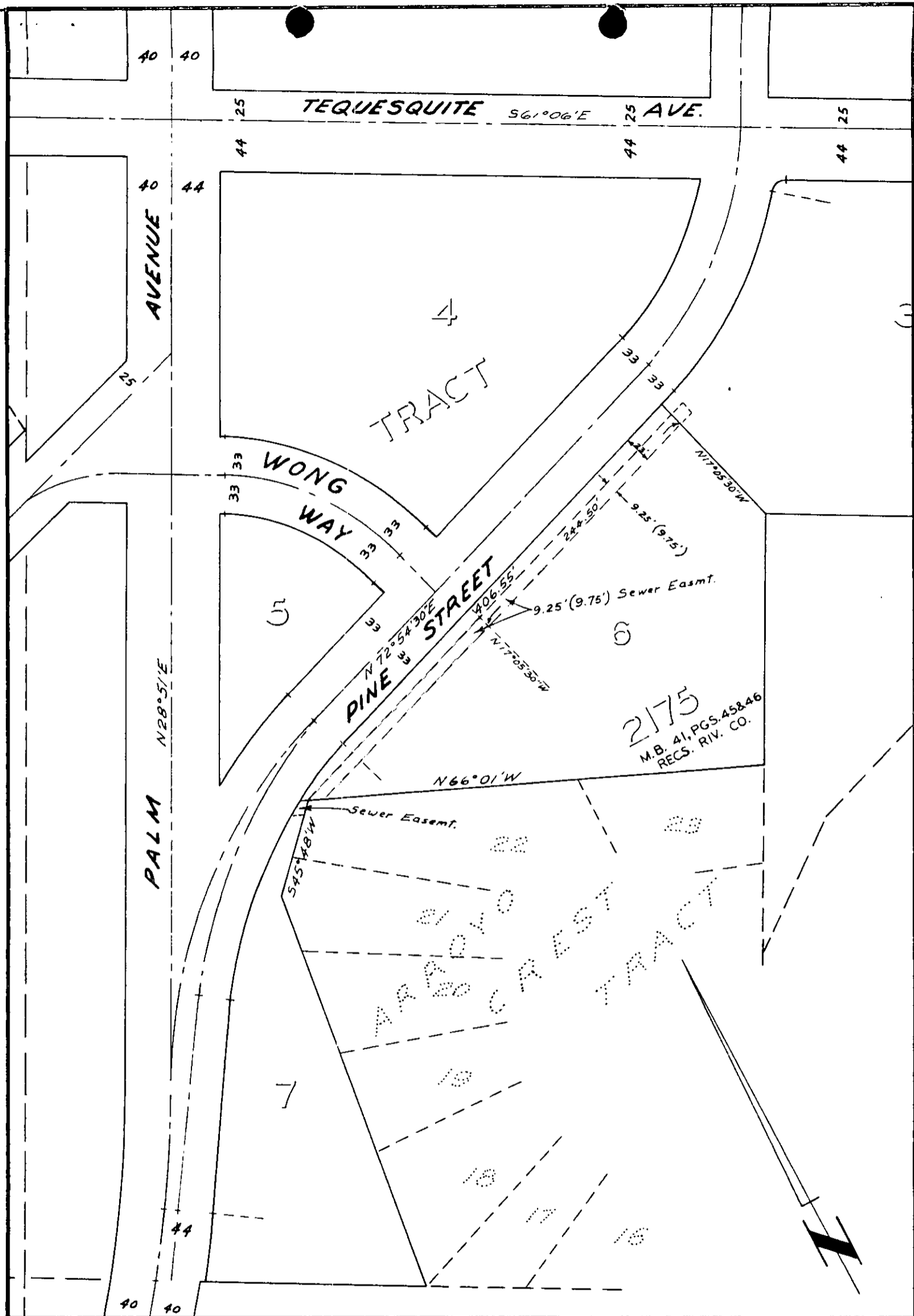
