A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PUBLIC UTILITY EASEMENT LYING WITHIN RECORD OF SURVEY NO. 682.

WHEREAS it appears that the City of Riverside has a public utility easement over and across Record of Survey No.682; and,

WHEREAS, it appears that said easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said easement be and the same is hereby vacated. The said easement is situate in the City of Riverside, County of Riverside, State of California, and described as follows:

That portion of a certain easement ten feet in width lying within Lots 5 and 12 of Division "A" of Hall's Addition to Riverside as shown on plat on file in Book 9, page 1 of Maps, Records of San Bernardino County, California, and within Lot 5, Block 17 of the Santa Fe Tract, as shown on plat on file in Book 6, page 14 of Maps, Records of San Bernardino County, California, and being that portion of the easement conveyed to the City of Riverside, a municipal corporation by deed recorded September 7, 1962, in Book 3216, page 549 of Official Records, Records of Riverside County, California, lying upon, over and across the northwesterly ten feet of Parcel 2 of a Record of Survey as shown on plat of Record of Survey on file in Book 37, page 86 of Records of Survey, Records of Riverside County, California.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.

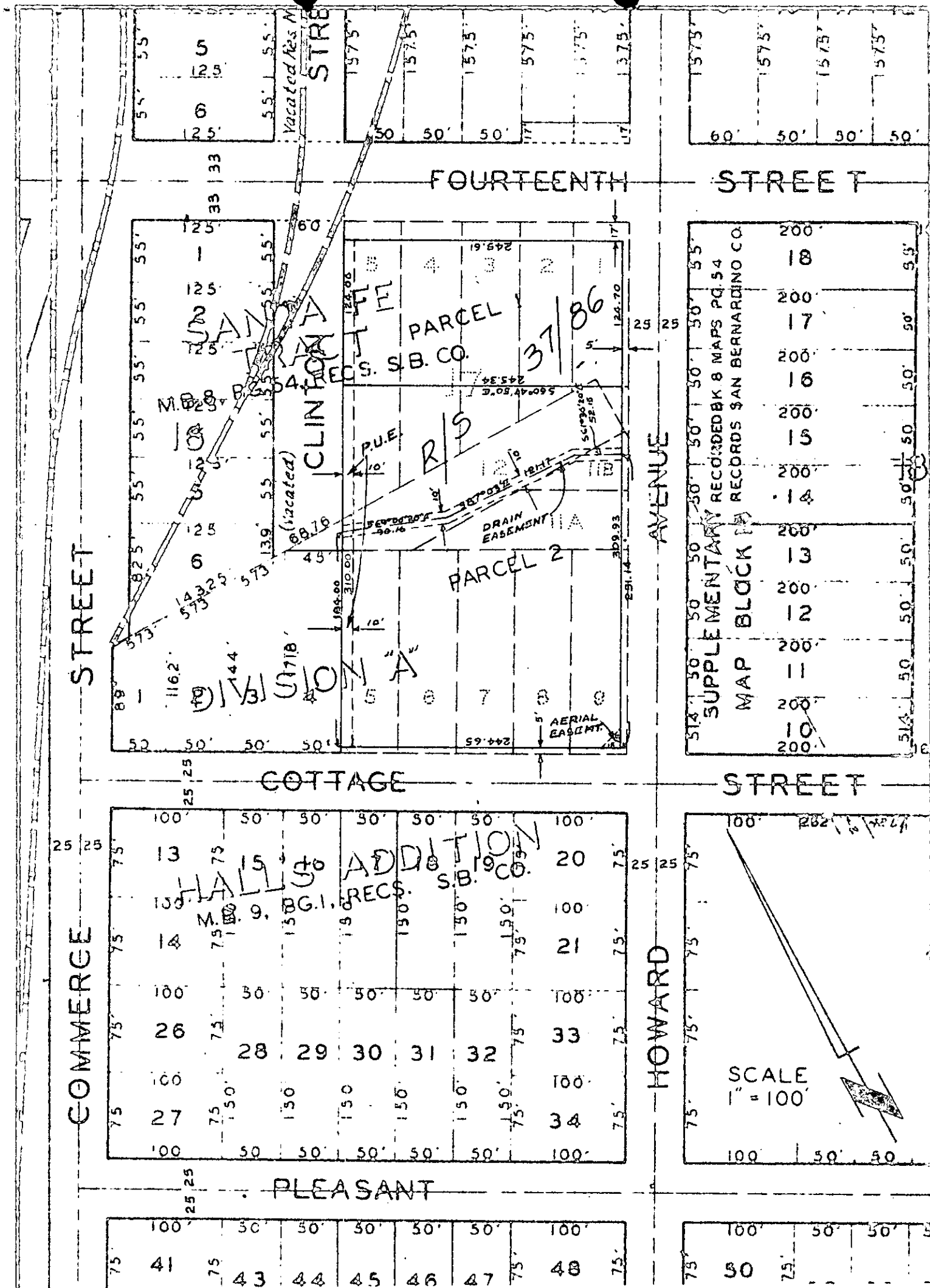
