RESOLUTION NO. 9588

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING THE DEDICATION OF PORTIONS OF CERTAIN STREETS LYING WITHIN JURUPA ADDITION TRACT NO.1 AND WITHIN SALT LAKE DEPOT TRACT TO PUBLIC USE FOR STREET PURPOSES.

BE IT RESOLVED by the City Council of the City of Riverside:

That the herein described parcels of land lying within Jurupa Addition Tract No.1 are hereby accepted by the City of Riverside to public use for street purposes to become and be known as portions of FLORENCE STREET and WILLIAM STREET. Said parcels of land are located in the City of Riverside, County of Riverside, State of California, and are described as follows:

Those portions of certain rejected streets lying within Jurupa Addition Tract No.1 on file in Book 6, page 41 of Maps, Records of Riverside County, California, described as follows:

All that certain rejected street 50 feet in width designated as FLORENCE STREET.

All that certain rejected street 50 feet in width designated as WILLIAM STREET.

BE IT FURTHER RESOLVED that the herein described parcels of land lying within Salt Lake Depot Tract are hereby accepted by the City of Riverside to public use for street purposes to become and be known as ANITA PLACE and a portion of SHEPPARD STREET. Said parcels of land are located in the City of Riverside, County of Riverside, State of California, and are described as follows:

Those portions of rejected streets lying within Salt Lake Depot Tract, on file in Book 6, page 54 of Maps, Records of Riverside County, California, described as follows:

All of that certain rejected street 60 feet in width designated as ANITA PLACE.

All of that certain rejected street of variable width designated as SHEPPARD STREET.
