A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, NAMING A PROPOSED COLLECTOR STREET AS EL CERRITO DRIVE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that pursuant to the recommendation of the Planning Commission of the City of Riverside the proposed collector street connecting Central Avenue with U. S. Route 60-395 in the City of Riverside described as follows:

All that certain proposed street, an 88 foot wide collector, connecting Central Avenue with U. S. Route 60-395 (Escondido Freeway) as above streets are shown on a map of Master Plan of Land Use and Circulation adopted by the City Council of Riverside in Resolution No. 9046, February 14, 1961,

be and the same is hereby named EL CERRITO DRIVE.

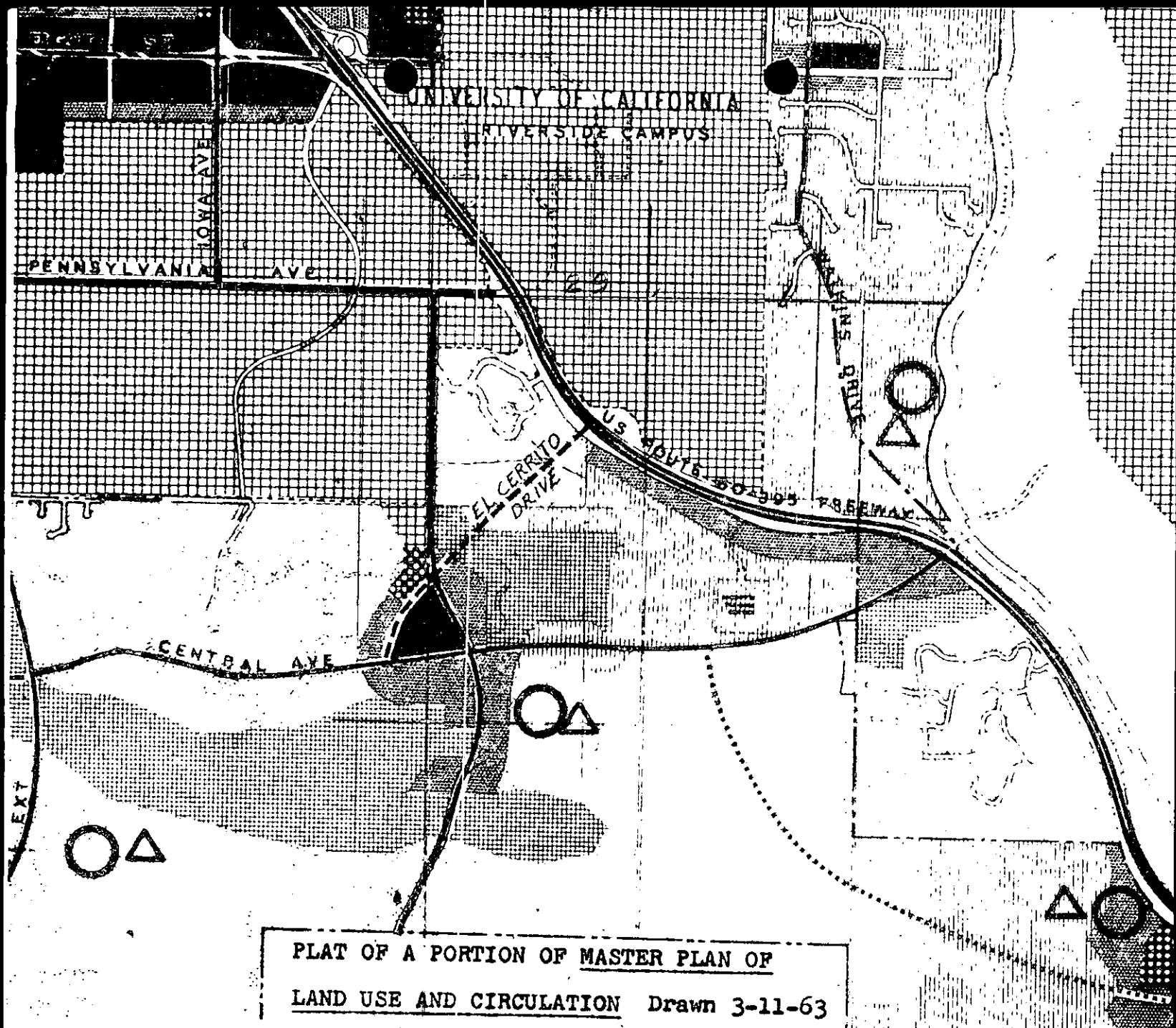



CIRCULATION ELEMENT

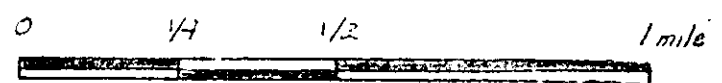
