

EASEMENTTHIS INDENTURE, made this 6th day of Sept., 1963by and between ~~MARTIN W. ROSENKRANTZ and EVA ROSENKRANTZ, husband and wife~~part 103 of the first part, and the CITY OF RIVERSIDE, a municipal corporation of the State of California, the party of the second part.

WITNESSETH:

THAT for a valuable consideration, receipt whereof is hereby acknowledged, said part 103 of the first part do ___ by these presents grant unto the said party of the second part, its successors and assigns, an easement and right of way for the construction, maintenance, operation, inspection, repair, replacement, and removal of electric lines and cables, including such additional lines as said grantee may from time to time in the future require, upon and by means of one line of poles, with supporting structures, crossarms, wires, anchors, fixtures, and appurtenances, for the transmission of electric energy for any and all purposes for which the same may be used, and communication purposes upon, over, and across that certain real property situated in the County of Riverside, State of California, described as follows:

The northerly 6 feet of the westerly 72.5 feet of that portion of Lots 3 and 4, Block 6 of the Lands of the Riverside Land and Irrigating Company as shown on map on file in Book 1, page 70 of Maps, Records of San Bernardino County, California, described as follows:

Commencing at a point in the southeasterly line of said Lot 3, 50 feet southwesterly from the easterly corner of said Lot 3;

Thence at right angles northerly to the northerly line of said Lot 3;

Thence westerly, 330 feet on the northerly line of said Lot to the TRUE point of beginning;

Thence southerly, 13 feet at right angles to said northerly line to the present southerly line of Arlington Avenue 66 feet wide for the TRUE point of beginning;

Thence continuing southerly, 253.38 feet (recorded 253.21 feet) at right angles to said northerly line to the southeasterly line of said Lot 3 in Block 6;

Thence southwesterly along said southeasterly line 158.58 feet to the southwesterly corner thereof;

Thence continuing southwesterly 15.78 feet (recorded 15.98 feet) along the southeasterly line of Lot 4 in Block 6 to a point in said southeasterly line;

Thence northerly and parallel with the easterly line of the herein described parcel to the southerly line of Arlington Avenue 66 feet wide;

Thence easterly along the southerly line of Arlington Avenue 145 feet to the point of beginning.

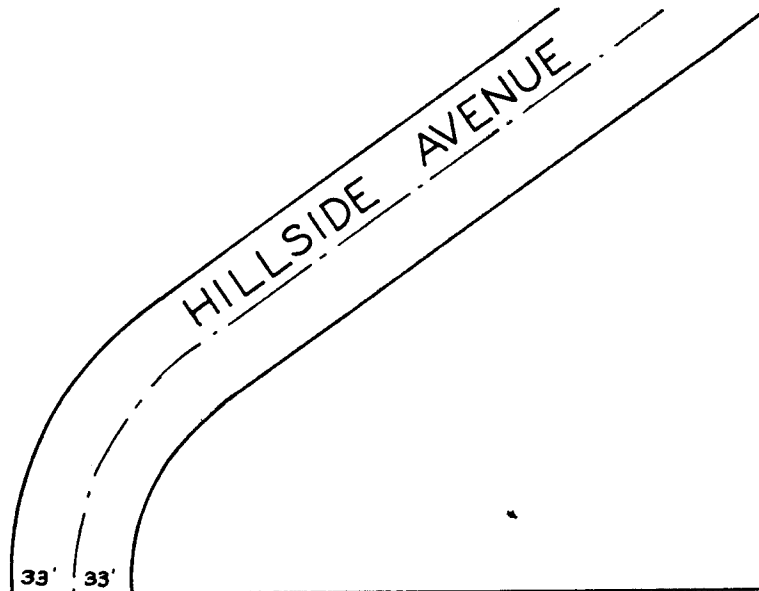
TOGETHER WITH the right of entry upon said premises over and across which said easement and right of way is granted, for the purposes of

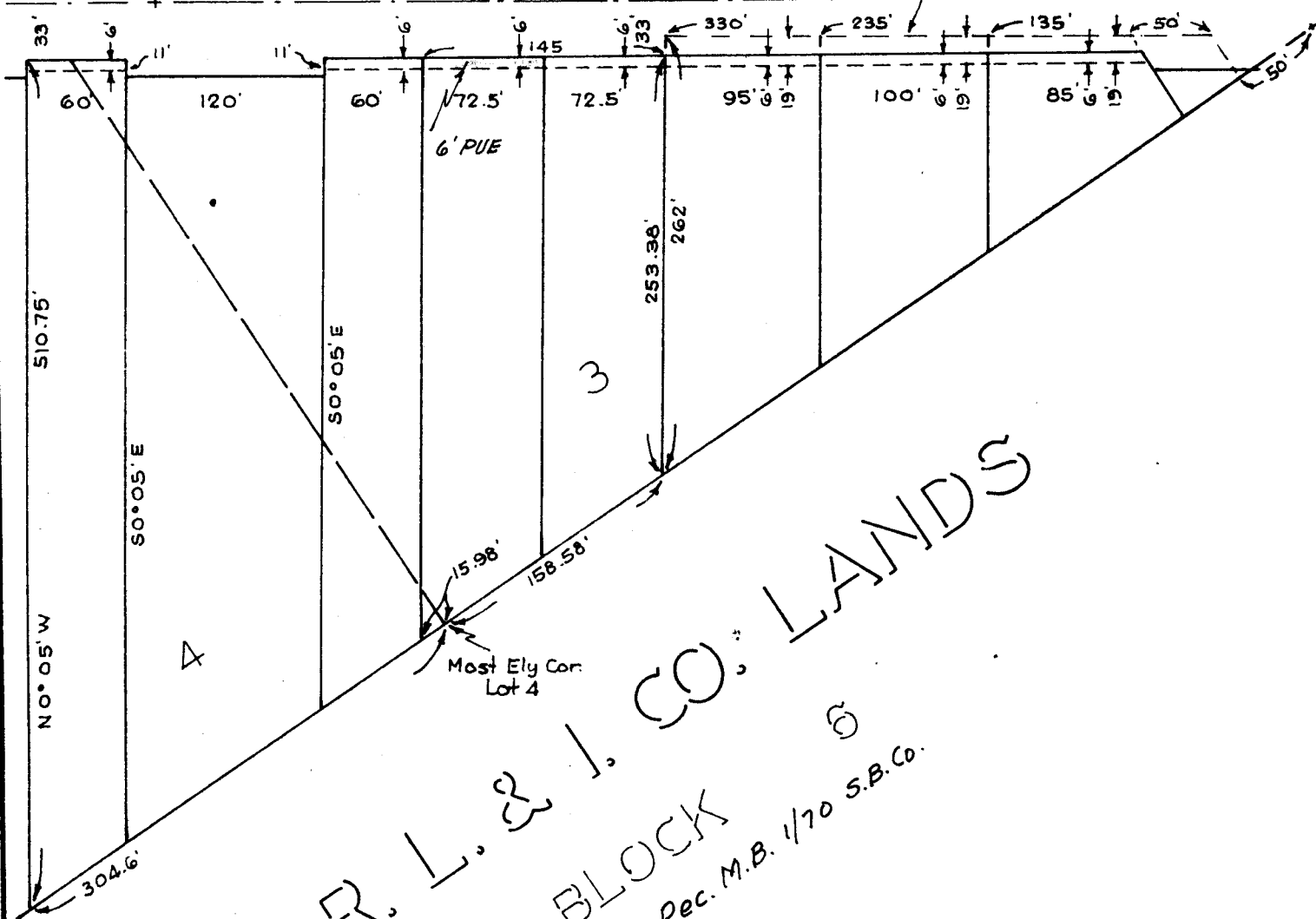
