A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF A PORTION OF SOLEDAD DRIVE TO WISTERIA DRIVE.

WHEREAS, the Planning Commission of the City of

Riverside has recommended and the City Council has determined that it is to the best interests of the City that the name of the hereinafter designated portion of Soledad Drive be changed,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the following described portion of SOLEDAD DRIVE

A portion of that certain street now known as Soledad Drive (a street of variable width) and being Lot "B" of Rainier Manor, as shown on plat on file in Book 36, pages 8 and 9 of Maps, Records of Riverside County, California;

EXCEPTING that portion of said Lot "B" lying westerly of the following described line: Beginning at the most easterly corner of Lot 23 of said Rainier Manor;

Thence North 34° 45' 30" East, 85.48 feet along the northeasterly prolongation of the southeasterly line of said Lot 23 to a point in the northerly line of said Lot "B", said point being the end of this described line,

be changed to WISTERIA DRIVE.
