2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING  
4 A PORTION OF ARROYO DRIVE.

5 WHEREAS, on October 1, 1963, the City Council of the City  
6 of Riverside adopted Resolution No. 9808 declaring its  
7 intention to order the vacation of a portion of Arroyo Drive and  
8 fixing the time and place for hearing all persons interested in  
9 the proposed vacation pursuant to the provisions of the Street  
10 Vacation Act of 1941, being Section 8300 et seq. of Part 3,  
11 Division 9 of the Streets and Highways Code of the State of  
12 California; and

13 WHEREAS, said proposed vacation was submitted to and  
14 acted upon by the Planning Commission of the City of Riverside,  
15 and notice of hearing said resolution was given as provided by  
16 said Street Vacation Act of 1941; and

17 WHEREAS, on the day fixed for the hearing the City  
18 Council heard and considered the evidence offered by persons  
19 interested and found, and hereby finds from all of the evidence  
20 submitted that the portion of the street hereinafter ordered  
21 vacated is unnecessary for present and prospective public use.

22 NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City  
23 Council of the City of Riverside, California, that the portion  
24 of the street located in the City of Riverside, County of  
25 Riverside, State of California, and described as follows:

26 That portion of Arroyo Drive ( a street of variable  
27 width) being that portion of Lot 2 of Victoria  
28 Arroyo Tract as shown by map on file in Book 8,  
29 page 49 of Maps, Records of Riverside County,  
California, lying within the following described  
parcel:

30 Commencing at Station 12 as shown on said map,  
31 said point being on the center line of Arroyo Drive  
and being also the most southerly corner of said Lot 2;  
32 Thence North 05° 42'30" West (recorded North 05°  
42' West) 53.00 feet along the westerly line of said  
lot to the beginning of a non-tangent curve concave

1 northerly and having a radius of 211 feet, the  
2 initial radial line at said point bearing South  
3 12° 37'35" West'

4 Thence leaving said westerly line and easterly  
5 along said curve through a central angle of 6° 37'  
6 35" an arc distance of 24.40 feet;

7 Thence South 84° 00' East, 63.44 feet to the  
8 beginning of a non-tangent curve concave southerly  
9 and having a radius of 92.50 feet, the initial  
10 radial line at said point bearing North 19° 46'34"  
11 West, said last mentioned point being the true point  
12 of beginning;

13 Thence easterly along said curve and along the  
14 northerly line of Arroyo Drive, through a central  
15 angle of 30° 53'34" an arc distance of 49.87 feet;

16 Thence South 78° 53' East, 39.70 feet along said  
17 northerly line of Arroyo Drive to the beginning of a  
18 non-tangent curve concave northerly and having a  
19 radius of 331.00 feet, the initial radial line at said  
20 point bearing South 04°15'42" East;

21 Thence leaving said northerly line of Arroyo Drive  
22 and westerly along said curve through a central angle  
23 of 10° 15'42" an arc distance of 59.28 feet;

24 Thence North 84° 00' West 29.05 feet to the point  
25 of beginning,

26 is unnecessary for present or prospective public use, and the  
27 same be and is hereby vacated.

28 IT IS FURTHER ORDERED that the City Clerk of said  
29 City of Riverside shall cause a certified copy of this order,  
30 attested by the City Clerk under the seal of said City, to be  
31 recorded in the office of the County Recorder of Riverside  
32 County, California.
