

1 RESOLUTION NO. 9876

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, CHANGING STREET NAMES.

4 WHEREAS, the Planning Commission of the City of Riverside
5 has recommended and the City Council has determined that it is
6 to the best interests of the City that the names of the herein-
7 after designated streets be changed,

8 NOW, THEREFORE, BE IT RESOLVED by the City Council of
9 the City of Riverside that the names of the hereinafter
10 designated streets are changed as follows:

11 SUFFIELD ROAD described as:

12 All that certain street of variable width now
13 known as Suffield Road and being Lot D of Jurupa
14 Grande Homes Unit No.1 as shown on map on file in
15 Book 26, page 44 of Maps, Records of Riverside
16 County, California,

17 be changed to MONA BELL COURT.

18 ALVARADO STREET described as:

19 Lot C of Tract 2605 as shown by map on file
20 in Book 48, page 10, Records of Riverside County;

21 Lot C of Braemar Terrace as shown by map on
22 file in Book 39, page 60 of Maps, Records of
23 Riverside County;

24 The northwesterly 30 feet of Lot 161 Lands
25 of the Southern California Colony Association and
26 that portion of Lot 160 Lands of the Southern
27 California Colony Association as shown by map on
28 file in Book 7, page 3 of Maps, Records of San
29 Bernardino County, lying between Lot C of Tract 2605
30 and Lot C of Braemar Terrace,

31 be changed to SAN ANDREAS AVENUE.
