RESOLUTION NO. 9934

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING THE DEDICATION OF PORTIONS OF AN ALLEY AND CERTAIN STREETS LYING WITHIN RIVERVIEW ADDITION TRACT NO. 3 TO PUBLIC USE FOR ALLEY AND STREET PURPOSES.

BE IT RESOLVED by the City Council of the City of Riverside:

That the herein described parcel of land located in the City of Riverside, County of Riverside, State of California, and described as

The westerly one-half of that certain 15 foot wide alley in Block 15 of Riverview Addition Tract No.3 adjoining Lots 10, 11 and 12 in Block 15 of Riverview Addition Tract No.3 as shown by map in Book 7, page 5 of Maps, Official Records of Riverside County, California,

be and is hereby accepted by the City of Riverside to public use for alley purposes.

That the herein described portions of Griffith Street and Liberty Street are hereby accepted by the City of Riverside to public use for street purposes to become and be known as portions of GRIFFITH STREET and LIBERTY STREET; said portions of streets being located in the City of Riverside, County of Riverside, State of California, and described as:

Those certain streets shown by map of Riverview Addition Tract No. 3 in Book 7, page 5 of Maps, Official Records of Riverside County, California, described as follows:

The easterly one-half of Griffith Street (50 feet wide) lying northerly of that certain strip of land conveyed to the Los Angeles and Salt Lake Railroad Company, a Utah corporation, by deed filed for record in the office of the County Recorder, Riverside County, California, March 5, 1962, as Instrument No.19982, and southerly of the westerly prolongation of the center line of Liberty Street;

TOGETHER WITH the southerly one-half of Liberty Street (40 feet wide) lying easterly of the northerly prolongation of the easterly line of Griffith Street and westerly of the northerly prolongation of the center line of that certain 15 foot wide alley in Block 15 of said Riverview Addition Tract No.3.
