> The northerly five feet of Lot 18 and the southerly five feet of Lot 19 of Belvedere Heights, as shown by map recorded in Book 22, page 31 of Maps, Records of Riverside County, California; EXCEPTING therefrom the most westerly five feet of said easements.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.
