2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING
4 PUBLIC UTILITY EASEMENTS IN LOTS 18 AND 19 OF
5 BELVEDERE HEIGHTS.

6 WHEREAS, it appears that the City of Riverside has
7 public utility easements over Lots 18 and 19 of Belvedere
8 Heights;and

9 WHEREAS, it appears that portions of said public utility
10 easements are no longer necessary for present or prospective
11 public use;

12 NOW, THEREFORE, IT IS ORDERED by the City Council of
13 the City of Riverside, California, that portions of said easements
14 be and the same are hereby vacated. That said portions of said
15 easements are situate in the City of Riverside, County of Riverside,
16 State of California, and described as follows:

17 The northerly five feet of Lot 18 and the southerly
18 five feet of Lot 19 of Belvedere Heights, as shown
19 by map recorded in Book 22, page 31 of Maps, Records
20 of Riverside County, California; EXCEPTING therefrom
21 the most westerly five feet of said easements.

22 IT IS FURTHER ORDERED that the City Clerk of said City of
23 Riverside shall cause a certified copy of this resolution and
24 order, attested by the City Clerk under the seal of said City, to
25 be recorded in the office of the County Recorder of Riverside
26 County, California.

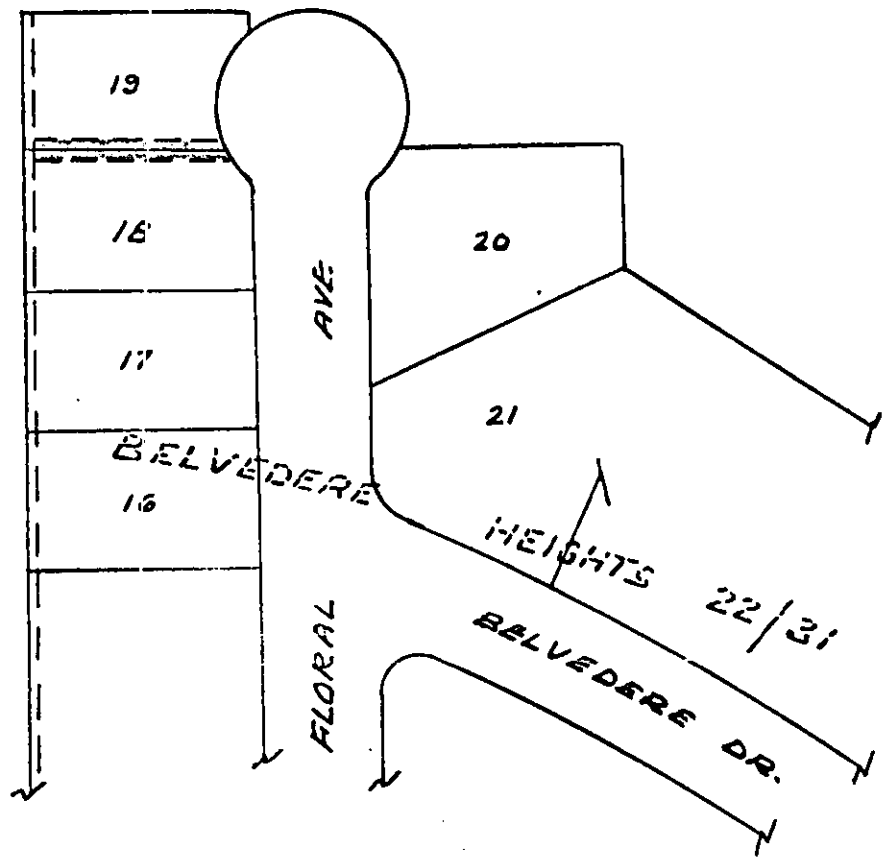
