be changed to BURTON STREET.

PROSPECT AVENUE described as:

Lot B of Campbell's La Sierra Subdivision as shown by map on file in Book 13, page 45 of Maps, Records of Riverside County, California,

be changed to EASY STREET.

LANDERS AVENUE described as:

Lot B of Gordon Acres Subdivision as shown by map on file in Book 38, page 16 of Maps, Records of Riverside County, California,

be changed to NIDEVER AVENUE.

ALICE COURT described as:

Lot E of Meyerscough Subdivision Unit No.1 as shown by map on file in Book 41, page 18 of Maps, Records of Riverside County, California,

be changed to SHAMEL COURT.


