RESOLUTION NO. 9990

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF ROSE WAY TO ARFON WAY.

WHEREAS the Planning Commission of the City of Riverside has recommended and the City Council has determined

that it is to the best interests of the City that the name of the hereinafter designated Rose Way be changed,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the following described ROSE WAY, being

That portion of Rubidoux Heights as shown by map on file in Book 6, page 22 of Maps, Records of Riverside County, California, described as follows:

Beginning at the northwesterly corner of Lot 5 of Rubidoux Heights;

Thence southwesterly along the northwesterly lines of Lots 5 and 8 and the southwesterly prolongation of Lot 8, 330.5 feet to a point in the northwesterly prolongation of the southwesterly line of said Lot 8;

Thence northwesterly on the prolongation of the southwesterly line of Lot 8, 25.0 feet to the most southerly corner of Lot 7 of said Rubidoux Heights;

Thence northeasterly along the southeasterly lines of Lots 7 and 6 and the northeasterly prolongation of Lot 6, 330.56 feet to a point in the northwesterly prolongation of the northeasterly line of Lot 5 of said Rubidoux Heights;

Thence southeasterly on the northwesterly prolongation of Lot 5, 25.0 feet to the point of beginning,

be changed to ARFON WAY.
