RESOLUTION NO. 10006

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF RESOLUTION OF INTENTION NO.9991; RESERVING EASEMENTS AND RIGHTS OF WAY AND DETERMINING THAT THE PUBLIC CONVENIENCE AND NECESSITY REQUIRE RESERVATION OF SUCH EASEMENTS AND RIGHTS OF WAY; AND MAKING ITS ORDER VACATING A PORTION OF AN ALLEY IN BLOCK 5, RANGE 5 OF THE TOWN OF RIVERSIDE.

WHEREAS on June 2,1964, the City Council of the City of Riverside adopted Resolution No. 9991 declaring its intention to order the vacation of a portion of an alley and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found and hereby finds from all of the evidence submitted that said portion of the alley ordered vacated is unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the said portion of the alley in the City of Riverside, County of Riverside, State of California, described as follows:

The southeasterly 10.0 feet of the northwesterly 175.0 feet of the northeasterly 198.0 feet of Block 5, Range 5 of the Town of Riverside as shown by map on file in Book 7, page 17 of Maps, Records of San Bernardino County, California;

RESERVING all permanent easements and rights of way of every nature as provided in Section 8330 and 8331 of the Streets and Highways Code over, across, upon or under the portion of said alley to be vacated,


be and the same is hereby vacated.


1 BE IT FURTHER RESOLVED that the City Council does hereby
 2 determine that the public convenience and necessity require
 3 the reservation of permanent easements and rights of way to
 4 construct, maintain, operate, replace, remove and renew sanitary
 5 sewers and storm drains and appurtenant structures in, upon,
 6 over and across the above described portion of the alley to
 7 be vacated and reserving the right to construct, maintain,
 8 operate, replace, remove, renew and enlarge lines of pipe,
 9 conduits, cables, wires, poles and other convenient structures,
 10 equipment and fixtures for the operation of gas pipe lines,
 11 telegraphic and telephone lines, and for the transportation and
 12 distribution of electric energy, petroleum and its products,
 13 water and incidental purposes, including access and the right
 14 to keep the property free from inflammable materials and wood
 15 growth and otherwise protect the same from all hazards in, upon
 16 and over the above described portion of the alley to be vacated.

17 IT IS FURTHER ORDERED that the City Clerk of said City
 18 of Riverside shall cause a certified copy of this order,
 19 attested by the City Clerk under the seal of said City to be
 20 recorded in the office of the County Recorder of Riverside
 21 County, California.



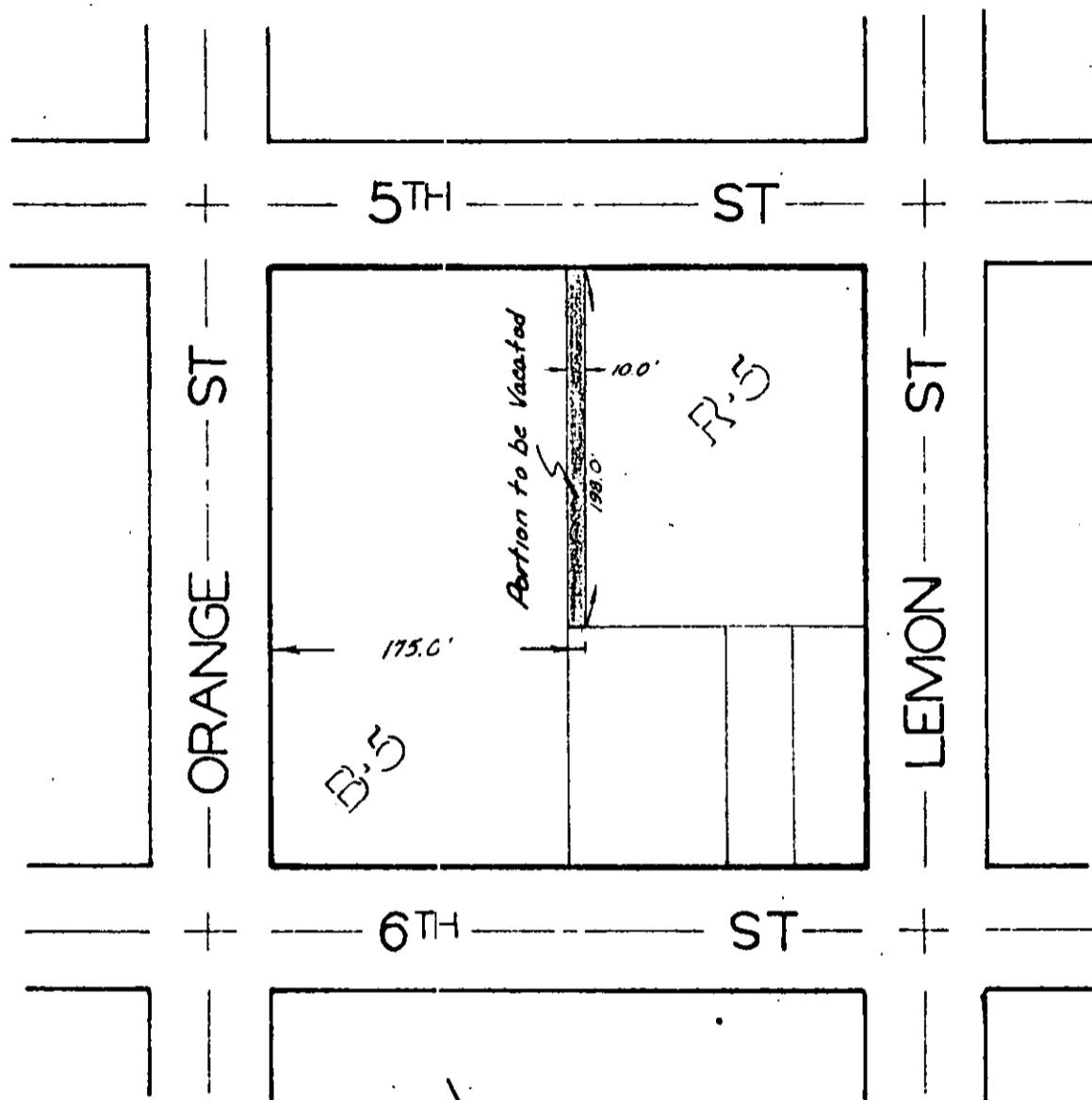
