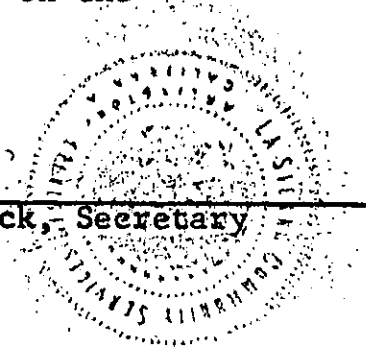
RESOLUTION ACCEPTING EASEMENT
