distance of 5.00 feet from the westerly corner of Parcel 32;

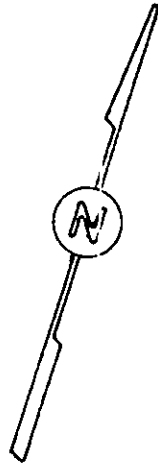

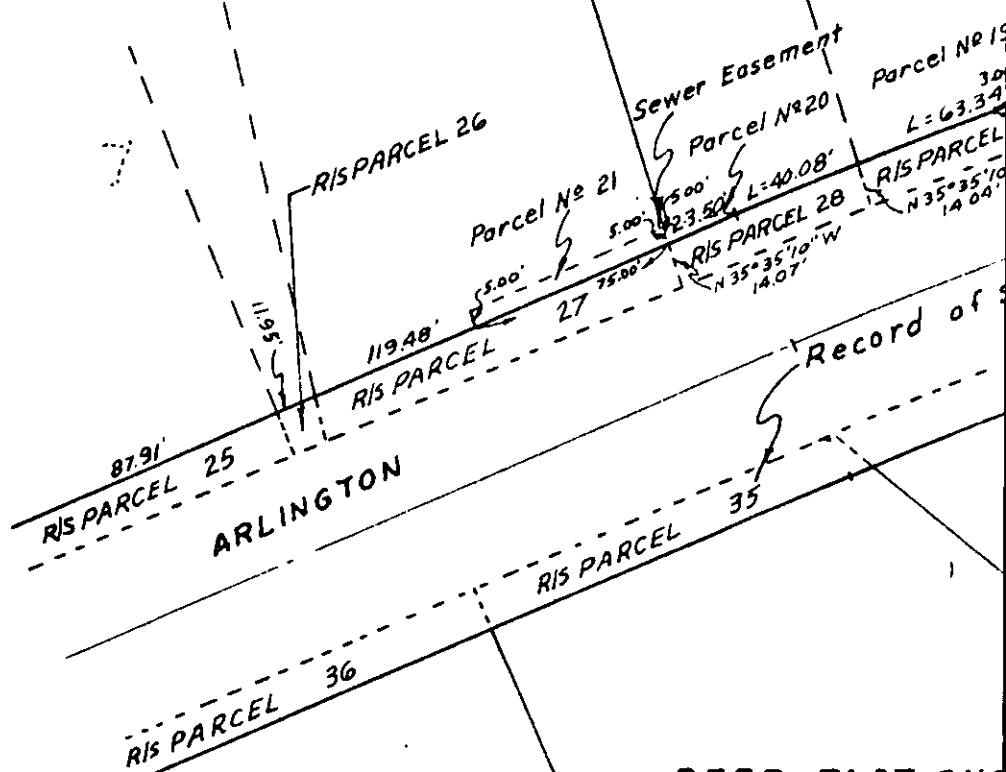

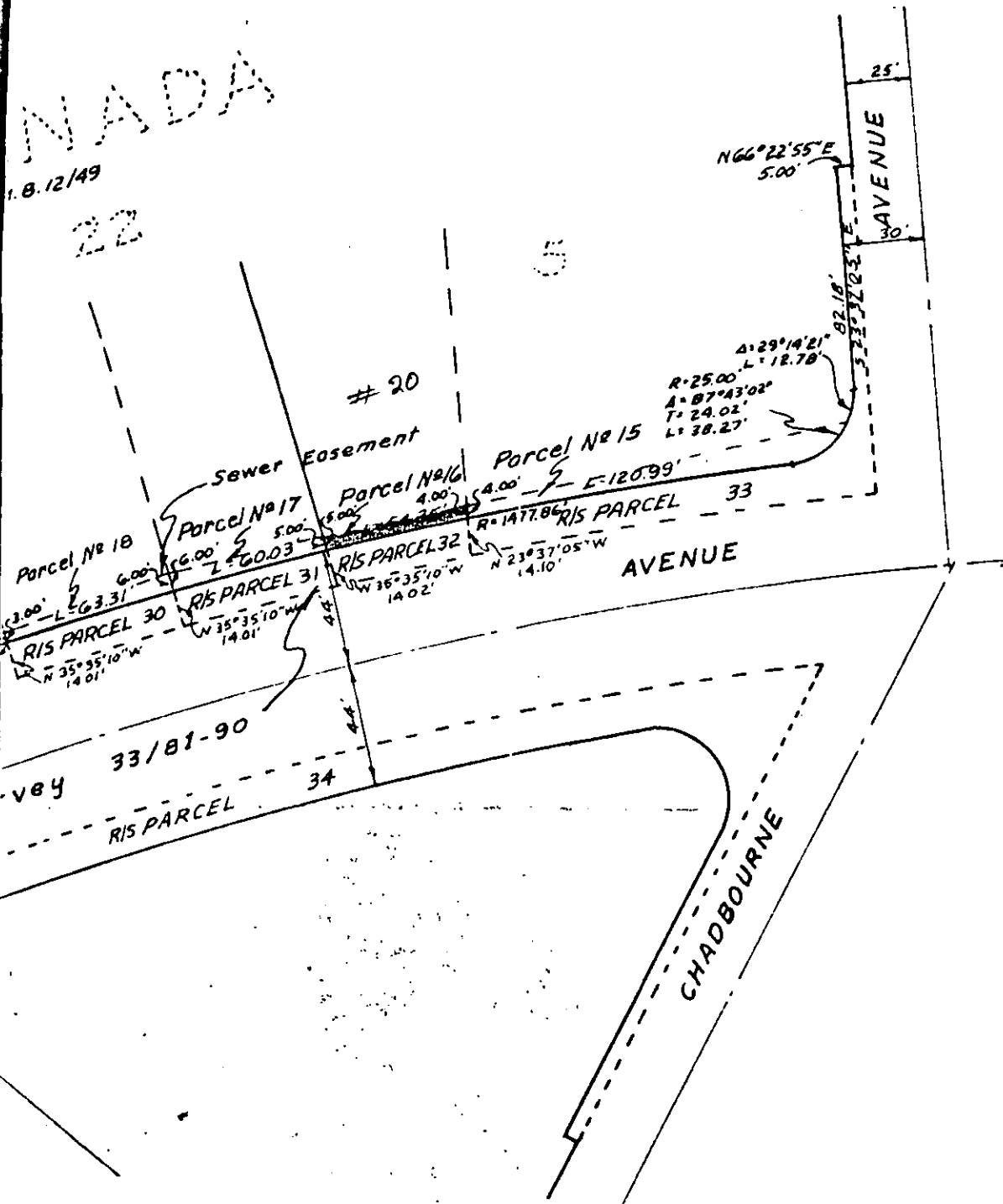
