A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF RESOLUTION OF INTENTION NO. 10041; RESERVING EASEMENTS AND RIGHTS OF WAY AND DETERMINING THAT THE PUBLIC CONVENIENCE AND NECESSITY REQUIRE RESERVATION OF SUCH EASEMENTS AND RIGHTS OF WAY; AND MAKING ITS ORDER VACATING A PORTION OF MYERS STREET.

WHEREAS on July 29, 1964, the City Council of the City of Riverside adopted Resolution No. 10041 declaring its intention to order the vacation of a portion of Myers Street and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found and hereby finds from all of the evidence submitted that said portion of Myers Street ordered vacated is unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the said portion of Myers Street in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Myers Street (60.00 feet wide) lying southeasterly of the southeasterly line of Indiana Avenue (80.0 feet wide) and northwesterly of the northwesterly line of the Atchison, Topeka and Santa Fe railway right of way, said street being a portion of Block 29 of the Lands of the Riverside Land and Irrigating Company as shown by map on file in Book 1, page 70 of Maps, Records of San Bernardino County, California, and

1 being a portion of that certain street deeded to
2 the City of Riverside by deed recorded January 14,
3 1896, in Book 32, page 187 of Deeds, Records of
4 Riverside County, California.

5 RESERVING all permanent easements and rights
6 of way of every nature as provided in Section 8330
7 and 8331 of the Streets and Highways Code over, across,
8 upon and under the portion of said street to be
9 vacated.

10 be and the same is hereby vacated.

11 BE IT FURTHER RESOLVED that the City Council does hereby
12 determine that the public convenience and necessity require
13 the reservation of permanent easements and rights of way to
14 construct, maintain, operate, replace, remove and renew sani-
15 tary sewers and storm drains and appurtenant structures in,
16 upon, over and across the above described portion of the street
17 to be vacated and reserving the right to construct, maintain,
18 operate, replace, remove, renew and enlarge lines of pipe,
19 conduits, cables, wires, poles and other convenient structures,
20 equipment and fixtures for the operation of gas pipe lines,
21 telegraphic and telephone lines, and for the transportation
22 and distribution of electric energy, petroleum and its products,
23 water and incidental purposes, including access and the right
24 to keep the property free from inflammable materials and wood
25 growth and otherwise protect the same from all hazards in,
26 upon and over the above described portion of the street to be
27 vacated.

28 IT IS FURTHER ORDERED that the City Clerk of said City
29 of Riverside shall cause a certified copy of this order,
30 attested by the City Clerk under the seal of said City to
31 be recorded in the office of the County Recorder of Riverside
32 County, California.

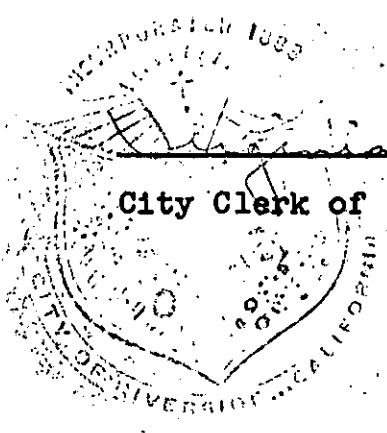

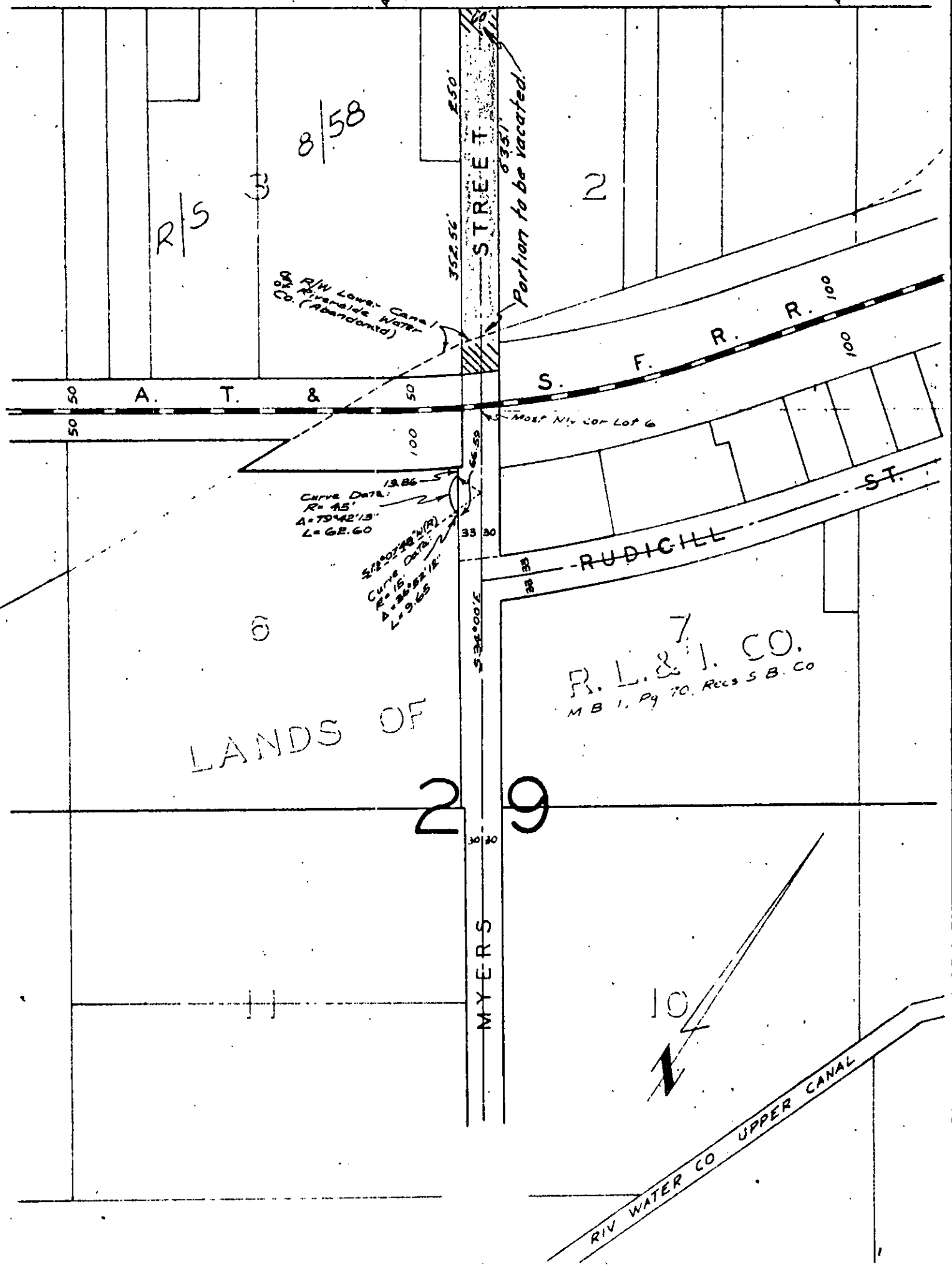
