A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PUBLIC UTILITY EASEMENT IN A PORTION OF LOT 2, BLOCK 22 OF ARLINGTON HEIGHTS.

WHEREAS it appears that the City of Riverside has a public utility easement over a portion of Lot 2, in Block 22 of Arlington Heights; and

WHEREAS it appears that a portion of said public utility easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that a portion of said easement be and the same is hereby vacated. That said portion of said easement is situate in the City of Riverside, County of Riverside, State of California, and described as follows:

That portion of Lot 2, Block 22 of Arlington Heights as shown by map on file in Book 11, pages 21 and 22 of Maps, Records of San Bernardino County, California, being a strip of land 10.0 feet wide, lying 5.0 feet on each side of the following described center line:

Commencing at a point in the southeasterly line of Lot 2 in said Block 22, 366.00 feet southwesterly from the most easterly corner thereof;

Thence North 34° 00' West parallel with the center line of Gibson Street (80.00 feet wide) 10.00 feet to the true point of beginning;

Thence continuing North 34° 00' West, parallel with the center line of said Gibson Street to a point in the southerly line of the Upper Canal of the Riverside Water Company.

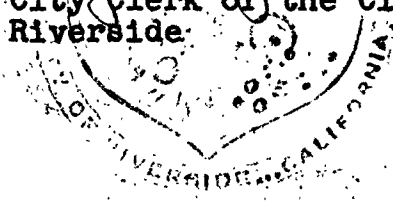

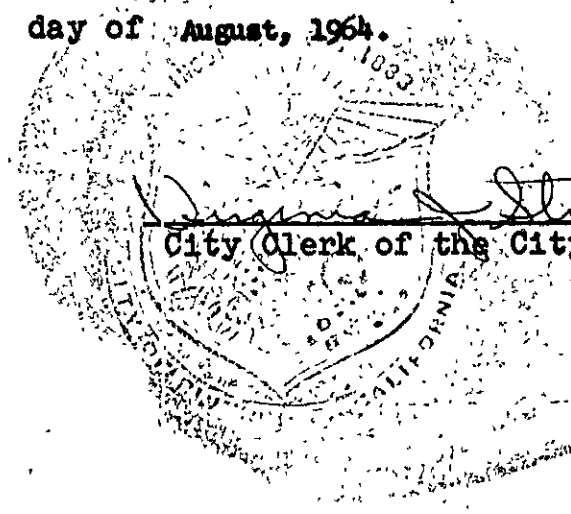
