

RESOLUTION NO. 10094

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A DRAINAGE EASEMENT LYING WITHIN A PORTION OF RECORD OF SURVEY NO. 804.

WHEREAS, it appears that the City of Riverside has a drainage easment over a portion of Record of Survey No. 804; and

WHEREAS, it appears that said drainage easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said drainage easement be and the same is hereby vacated. That said easement is situated in the City of Riverside, County of Riverside, State of California, and described as follows:

All that portion of a certain drainage easement deeded to the City of Riverside by deed recorded in Book 544, page 394 of Official Records, Records of Riverside County, California, lying northwesterly of the northwesterly line of Raintree Avenue (66 feet wide) and southeasterly of the southeasterly line of Lot 1 of Mueller Tract as shown by map on file in Book 37, page 26 of Maps, Records of Riverside County, California, the center line of said drainage easement being parallel with and 25 feet at right angles southwesterly from the northeasterly line of Lot 9, Block 7 of the lands of the Riverside Land and Irrigating Company as shown by map on file in Book 1, page 70 of Maps, Records of San Bernardino County, California.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.

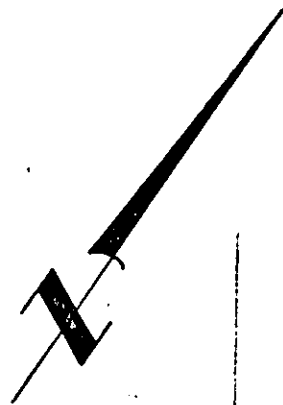

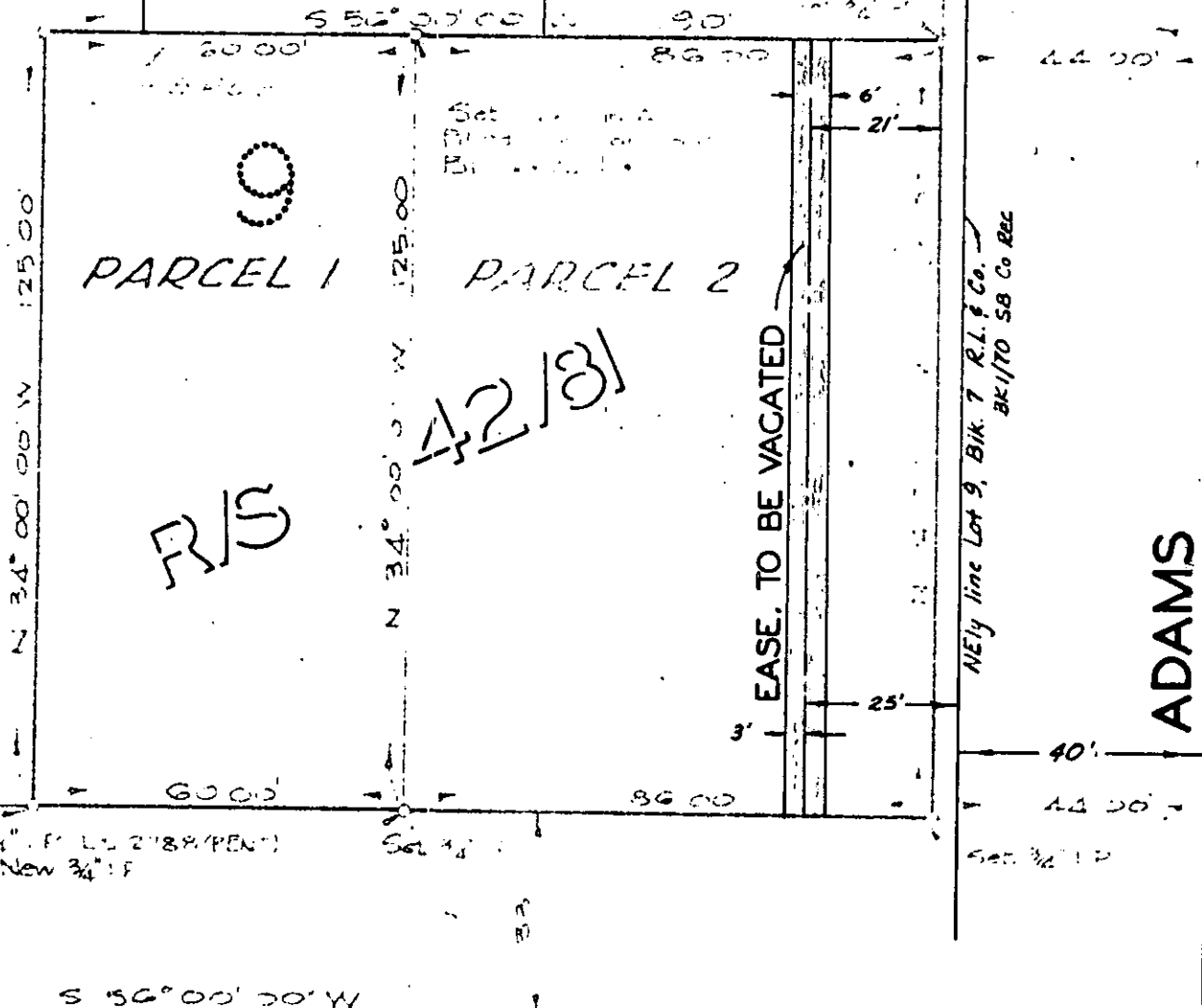
