

RESOLUTION NO. 10126

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PUBLIC UTILITIES EASEMENT LYING WITHIN TRACT NO. 2327.

WHEREAS, it appears that the City of Riverside has a public utilities easement over a portion of Tract 2327; and

WHEREAS, it appears that said public utilities easement is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said public utilities easement be and the same is hereby vacated. That said easement is situated in the City of Riverside, County of Riverside, State of California, and described as follows:

That portion of that certain aerial easement for public utilities conveyed to the City of Riverside by deed recorded January 10, 1964, as Instrument No. 3862 Official Records of Riverside County, lying within Lots 13 and 14 as shown on map of Tract 2327 on file in Book 47, page 97 of Maps, Riverside County Records;

EXCEPTING therefrom any portions lying within the dedicated public utilities easements shown upon said map of Tract 2327.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.


